

DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned Jetter Brewing Company of Omaha, Nebraska, a corporation organized and existing under the laws of the State of Nebraska, hereby certifies that it is the sole owner and proprietor of the following described premises, and that it does hereby dedicate to the public for use as a street the following described property situated in Douglas County, Nebraska, to-wit:

A strip of land in widths as hereinafter designated and situated on both sides of a line running from a point on the west line of 30th Street in the City of Omaha, Nebraska, and 204 ft. south of the south line of Y Street in Omaha, Nebraska, to a point 467 ft. west of said 30th Street and 183.5 ft. south of the south line of said Y Street; the first 400 ft. of said strip lying immediately west of said 30th Street to lie 15 ft. on each side of the aforescribed line, the last 67 ft. of said strip, which is west of and immediately adjoining the first 400 ft. of said strip, to lie 25 ft. on each side of the afore-described line, it being understood that the first 400 ft. of said strip as above described is 30 ft. wide and the last 67 ft. of said strip as above described is 50 ft. wide,

subject, however, to the right of the undersigned to maintain under the surface of said property water pipes which are now serving property belonging to the undersigned.

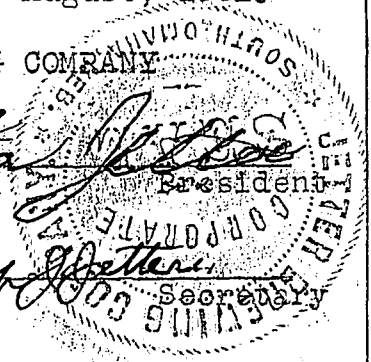

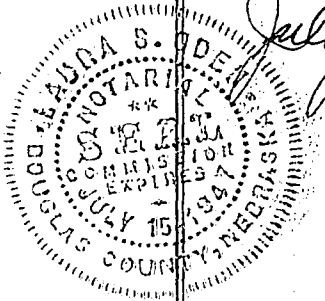
