WITNESSETH THAT:

WHEREAS, Northern is the owner of an easement grant dated August 12, 1940, covering:

South One Fourth of the North Four Fifths of the Northeast Quarter $(S^{\frac{1}{1_1}} N \frac{1}{4}/5 NE^{\frac{1}{1_1}})$ of Section 3, Township $1^{\frac{1}{4}}$, Range 12, Douglas County, Nebraska,

which easement was recorded in Book 148 of Misc., on Page 219 in the Office of the Register of Deeds in and for Douglas County, Nebraska; and also an Easement Grant dated August 7, 1940, covering:

South One-Third (S 1/3) of North Three-Fifths (N 3/5) of Northeast One-Fourth (NE $\frac{1}{4}$) of Section 3, Township 14, Range 12, Douglas County, Nebraska,

which easement was recorded in Book 148 of Misc., on Page 221 in the Office of the Register of Deeds in and for Douglas County, Nebraska; and

WHEREAS, pursuant to the authority contained in said Easement Grant Northern has constructed and currently operates and maintains a 4-inch natural gas pipe line through and across the premises above described; and

WHEREAS, the parties hereto desire to more clearly define their rights under such Easement Grant and further desire to modify and amend said Easement Grant in certain respects.

NOW THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter set forth, it is hereby agreed by and between Northern and Owner as follows:


- 1. Northern shall and by these presents does restrict its right-of-way to a strip of land across the land described above as presently owned by Owner, which strip is depicted on the sketch attached hereto, marked Exhibit "A" and by this reference is made a part hereof.
- 2. Said Easement Grant hereinabove described shall remain in full force and effect as it presently exists except as modified and amended hereby.
- 3. Owner shall not build, create or construct nor cause or permit to be constructed any building, structure or other obstruction upon the strip of land above described.

Notwithstanding any limitations stated or implied in such original Easement Grant, Northern shall and by these presents does have the right, privilege and authority to lay, construct, maintain, operate, inspect, alter, repair, remove, change the size of or replace at any time, or from time to time, one or more additional pipelines at such locations upon said strip of land as it may choose. For each additional line which Northern constructs upon said strip of land, it shall pay Owner the consideration agreed to in said original Easement Grant within a reasonable time subsequent to the completion of the construction thereof.

This instrument and the covenants and agreements herein contained shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
