REFERRING TO THE NORTHEAST CORNER OF SAID QUARTER SECTION; THENCE WESTERLY A DISTANCE OF 364.92 FEET ALONG THE NORTH LINE OF SAID QUARTER SECTION TO THE POINT OF BEGINNING; THENCE WESTERLY DEFLECTING 000 DEGREES, 00 MINUTES A DISTANCE OF 461.47 FEET ALONG THE NORTH LINE OF SAID QUARTER SECTION; THENCE EASTERLY DEFLECTING 161 DEGREES, 21 MINUTES LEFT, A DISTANCE OF 144.19 FEET; THENCE SOUTHWESTERLY DEFLECTING 108 DEGREES, 09 MINUTES RIGHT, A DISTANCE OF 804.22 FEET; THENCE SOUTHWESTERLY DEFLECTING 012 DEGREES, 33 MINUTES LEFT, A DISTANCE OF 341.70 FEET; THENCE SOUTHERLY DEFLECTING 014 DEGREES, 00 MINUTES LEFT, A DISTANCE OF 350.80 FEET TO A POINT ON THE SOUTH LINE OF THE PROPERTY OWNED BY THE GRANTOR(S); THENCE EASTERLY DEFLECTING 101 DEGREES, 18 MINUTES LEFT, A DISTANCE OF 193.44 FEET ALONG THE PROPERTY LINE OF THE GRANTOR(S); THENCE NORTHERLY ON A 2206.83 FOOT RADIUS CURVE TO THE RIGHT, DEFLECTION TO THE INITIAL TANGENT BEING 078 DEGREES, 43 MINUTES LEFT, A DISTANCE OF 1042.93 FEET, SUBTENDING A CENTRAL ANGLE OF 027 DEGREES, 05 MINUTES; THENCE NORTHEASTERLY DEFLECTING 002 DEGREES, 46 MINUTES RIGHT, A DISTANCE OF 470.74 FEET; THENCE EASTERLY DEFLECTING 028 DEGREES, 40 MINUTES RIGHT, A DISTANCE OF 103.37 FEET TO THE POINT OF BEGINNING CONTAINING 6.47 ACRES, MORE OR LESS, WHICH INCLUDES 2.99 ACRES, MORE OR LESS PREVIOUSLY OCCUPIED AS PUBLIC HIGHWAY.

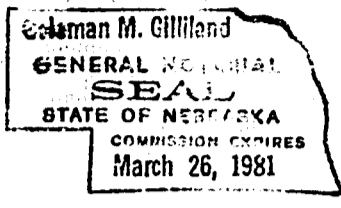
