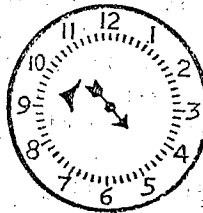

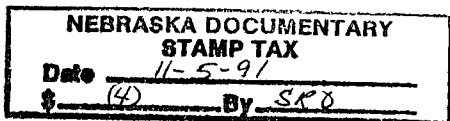

Flat of a tract of land comprising all of Tract 3 and Tract 4 in the South Half (S1/2) of Section Thirty-Three (33), Township Sixteen (16) North, Range Three (3) West, and in the Northeast Quarter (NE1/4) of Section Four (4), Township Fifteen (15) North, Range Three (3) West of the 6th P.M., Merrick County, Nebraska, more particularly described as follows:

First to ascertain the actual point of beginning, start at the Southwest corner of said South Half (S1/2) of Section Thirty-Three (33); thence Easterly along and upon the South line of said South Half (S1/2), a distance of Nine Hundred Fifteen (915.00) feet to the actual point of beginning; thence continuing along and upon the South line of said Section Thirty-Three (33), a distance of One Thousand Seven Hundred Fifty-One and Sixty-Two Hundredths (1751.62) feet to the South Quarter (S1/4) corner of said South Half (S1/2); thence continuing along and upon the South line of said South Half (S1/2), a distance of One Hundred Sixty-Five and Sixty Hundredths (165.60) feet; thence deflecting right $29^{\circ}26'00''$ and running Southeasterly for a distance of One Thousand Two Hundred Fifty-Nine and Fifty Hundredths (1259.50) feet; thence deflecting left $39^{\circ}20'20''$ and running Northeasterly in said Section Four (4), a distance of One Hundred Twenty and Twelve Hundredths (120.12) feet; thence deflecting left $32^{\circ}19'40''$ and running Northeasterly for a distance of Two Hundred Twenty and Twenty-Five Hundredths (220.25) feet to a point on the Westerly right-of-way line of Highway # 39; thence deflecting left $70^{\circ}05'20''$ and running Northwesterly for a distance of Three Hundred Thirty-Eight and Fifty-Five Hundredths (338.55) feet along and upon the Westerly right-of-way line of said Highway # 39; thence deflecting left $3^{\circ}40'40''$ and running Northwesterly for a distance of One Hundred Twenty-One and Ninety Hundredths (121.90) feet; thence deflecting left $60^{\circ}19'40''$ and running Westerly for a distance of Seven and Five Hundredths (7.05) feet; thence deflecting right $83^{\circ}32'20''$ and running Northerly for a distance of Thirteen and Eighteen Hundredths (13.18) feet to a point of curvature; thence Northwesterly on a 981.74 radius curve to the left (initial tangent of which coincides with the last described course) a distance of Nine Hundred Thirty-Two and Sixty-Eight Hundredths (932.68) feet to a point of tangency; thence continuing Northwesterly on a line which forms an angle of $27^{\circ}14'40''$ left from the final tangent of the last described curve a distance of One Thousand Two Hundred Twenty-Eight and Eighty-One Hundredths (1228.81) feet; thence deflecting right $7^{\circ}51'20''$ and running Northwesterly for a distance of Two Hundred Forty-Seven and Thirty Hundredths (247.30) feet; thence deflecting right $10^{\circ}59'20''$ and running Northwesterly for a distance of Three Hundred Twenty-Seven and Ninety-Three Hundredths (327.93) feet to a point of curvature; thence Northwesterly on a 976.47 foot radius curve to the right (initial tangent of which coincides with the last described course) a distance of Three Hundred Sixty-One and Sixty-Eight Hundredths (361.68) feet to a point of tangency; thence continuing Northwesterly on a line which forms an angle of $10^{\circ}32'00''$ right from the final tangent of the last described course for a distance of Two Hundred and Sixty-Five Hundredths (265.79) feet to a point of intersection with the Westerly right-of-way line of Highway # 39 and the Southerly right-of-way line of U.S. Highway # 30; thence Southwesterly along and upon the Southerly right-of-way of U.S. Highway # 30, for a distance of Six Hundred Five and Twenty-Seven Hundredths (605.27) feet to a point on the East line of Tract 2; thence Southeasterly along and upon the East line of said Tract 2, a distance of Five Hundred Ninety-Two and Twenty-Six Hundredths (592.26) feet to a point on the Northerly line of said Tract 2; thence Easterly along and upon the Northerly line of said Tract 1, a distance of Two Hundred Fourteen and Thirty-One Hundredths (214.31) feet to the Northeast corner of said Tract 1; thence Southerly along and upon the East line of said Tract 1, a distance of Four Hundred Twenty (420.00) feet to the actual point of beginning and containing 56.863 acres, more or less.
