ORDINANCE NO. 55

AN ORDINANCE creating, establishing and opening a new avenue in the Village of Bellevue to be known as "Boulevard Avenue," prescribing its width and designating its location.

Be it Ordained by the Chairman and Board of Trustees of the Village of Bellevue, Nebraska:

Section 1. That a new avenue 100 feet in width, commencing at the northwest corner of block 238, in said village of Bellevue; and running thence southeasterly to the northwest portion of block 206, and thence south to the middle portion of the west half of the block 202, and thence southwesterly to the southwest corner of block 365, and through portions of blocks 233, 207, 206, 205, 204, 203, 202, 244, 245, 272, 271, 274, 275, 298, 297, 304, 305, 324, 323, 335, 336, 349, 348 and 365, of said village, as shown by the survey heretofore made of said proposed new avenue, and the map thereof now on file in the office of the clerk of said village, is hereby created, established and opened as a public thoroughfare in said village, to be called Boulevard Avenue.

Section 2, This ordinance shall take effect and be in force from and after its passage, approval and publication.

ORDINANCE NO. 56

An Ordinance granting to the Omaha & Southern Interurban Railway Company, its successors and assigns, the right to construct and operate a railroad upon Boulevard Avenue in the Village of Bellevue.

Be it Ordained by the Chairman and Board of Trustees of the Village of Bellevue, Nebraska:

Section 1. That there is hereby granted and confirmed unto the Omaha & Southern Interurban Railway Company, its successors and assigns, the right of way along and upon and through Boulevard Avenue from the Northwest corporate limits to the southwest corporate limits of the Village of Bellevue.

Section 2. Said Omaha & Southern Interurban Railway Company shall have the right to construct maintain and operate a line of railroad along upon and through said boulevard, said railroad to be constructed to conform as near as may be to a grade to be determined by the engineer of said Omaha & Southern Interurban Railway Company as shown by a profile prepared by the engineer of said Company.

Section 3. This ordinance shall take effect and be in force from and after its passage, approval and publication.
