ORDINANCE NO. 118.

AN ORDINANCE vacating said portions of hereinafter specifically described streets and avenues in the Village of Bellevue, Sarpy County, Nebraska.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, SARPY COUNTY, NEBRASKA.

Section I. The Board of Appraisers heretofore appointed by this Board of Trustees for the purpose of making an assessment, whose duty it was to fix, appraise, determine and assess the damages sustained by any citizen of the Village of Bellevue or any property owner thereof by the vacation of the hereinafter described portions of streets and avenues, having reported that in their judgment no damages had been sustained by any citizen or owner of property in said Village of Bellevue, Sarpy, County, Nebraska. That it is necessary and expedient for the public good and it having been recommended by said Board of Appraisers to vacate the following portions of the streets and avenues in the Village of Bellevue, Nebraska, to-wit:

A strip of land 17 feet wide on each outer edge of each street in said Village of Bellevue, as a strip of land 17 feet wide abutting upon each side of each and every Block in said Village of Bellevue and said strip dedicated for parking purposes only and being that portion of each side of each street between the sidewalk line and the lot line of each and every block in the said Village of Bellevue. Said strip of land being specifically described as the West 17 feet of Bluff Street, beginning at the North line of the Bellevue Common and running North to the intersection with the South line of 7th Avenue and abutting upon the West line of Blocks 1-2-3-4-5-6-7 and 8 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue, 12th Avenue, 11th Avenue, 10th Avenue, 9th Avenue, 8th Avenue, cross Bluff Street; the West 17 feet of Bluff Street beginning at the North line of the Bellevue Common and running North to the intersection with the South line of 7th Avenue and abutting upon the East side of Blocks 16-17-18-19-20-21-22 and 23 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue, 12th Avenue, 11th Avenue, 10th Avenue, 9th Avenue, and 8th Avenue cross Bluff Street; the East 17 feet of Warren Street beginning at the North line of Bellevue Common and running to the intersection with the South line of 7th Avenue and abutting on the West side of Blocks 16-17-18-19-20-21-22 and 23 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue, 12th Avenue, 11th Avenue, 10th Avenue, 9th Avenue and 8th Avenue cross Warren Street; the West 17 feet of Warren Street beginning at the North line of the Bellevue Common and running North to the intersection with the South line of 7th Avenue and abutting upon the East side of Blocks 66-67-68-69-Jefferson Square, Blocks 71-72 and 73 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue, 12th Avenue, 11th Avenue, 10th Avenue, 9th Avenue and 8th Avenue cross Bluff Street; the East 17 feet of Main Street beginning at the North line of the Bellevue Common running North to the intersection with 7th Avenue and abutting upon the West side of Blocks 71-72 and 73 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue, 12th Avenue, 11th Avenue, 10th Avenue, 9th Avenue and 8th Avenue cross Main Street; the West 17 feet of Main Street beginning at the North line of the Bellevue Common and running North to the intersection with the North line of 7th Avenue produced West and abutting upon the East side of that portion of 7th Avenue

previously vacated, Block 88, that portion of 11th Avenue previously vacated, Blocks 92-93-94 and 95 but not including the street and avenue intersections formed at the points where 13th Avenue, Cemetery Avenue and 12th Avenue cross Main Street and not including that portion of the Boulevard running diagonally across Block 92; the North 17 feet of 7th Avenue beginning at the East line of that portion of 7th Avenue previously vacated and running East to the Village limits, abutting upon the South line of Block 9, the South line of the North portion of Bluff Street previously vacated, the South line of Block 15, the South line of the North portion of Warren Street, previously vacated, the South line of Block 74, the South line of the North portion of Main Street previously vacated; the South 17 feet of 7th Avenue beginning at a point 17 feet West of the North West corner of Block 73 running due North 17 feet, thence due East along a line parallel to the North line of Block 73-16 and 8, to the East Village limits, thence South Easterly to the North East corner of lot 6 Block 8, thence West to the point of beginning not including therein the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 7th Avenue; the North 17 feet of 8th Avenue beginning at a point 17 feet west of the South West corner of Block 73, running East to the East Village limits and abutting upon the South line of Blocks 73-16-8 but not including the street and Avenue intersections formed at the points where Warren Street and Bluff Street cross 8th Avenue; the South 17 feet of 8th Avenue beginning at a point 17 feet West of the North West corner of Block 72 running East to the East Village limits and abutting upon the North line of Blocks 72-17 and 7 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Streets cross 8th Avenue; the North 17 feet of 9th Avenue beginning at a point 17 feet West of the South West corner of Block 72, running East to the East Village limits and abutting upon the South line of Blocks 72-17 and 7 but not including the street and avenue intersections formed at the points where Warren and Bluff Street cross 9th Avenue; the South 17 feet of 9th Avenue beginning at a point 17 feet West of the North West Corner of Block 71, running East to the intersection with the East Village limits and abutting upon the North line of Block 71-18 and 6 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 9th Avenue; the North 17 feet of 10th Avenue beginning at a point 17 feet West of the South West corner of Block 71 and running East to the East Village limits and abutting upon Blocks 71 and running East to the East Village limits and abutting upon Blocks 71-18 and 6 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 10th Avenue; the South 17 feet of 10th Avenue beginning at a point 17 feet West of the North West corner of Jefferson Square running East to the East Village limits and abutting upon the North line of Jefferson Square, Blocks 19 and 5 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 10th Avenue; the North 17 feet of 11th Avenue beginning at a point 17 feet West of the South West corner of Jefferson Square and running East to the East Village limits and abutting upon the South line of Jefferson Square, Blocks 19 and 5 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 11th Avenue; the South 17 feet of 11th Avenue beginning at a point 17 feet West of the North West corner of Block 69 and running East to the East Village limits and abutting upon the North line of Blocks 69-20 and 4 but not including the street and avenue intersections formed at the points where Warren Street and Bluff Street cross 11th Avenue; the North 17 feet of 12th Avenue beginning at the West Village limits running East to the East Village limits and abutting upon the South line of Blocks 4-20-49-92-140-163-211 and 254 but not including the street and avenue inter-
