WARRANTY DEED

GERALD M. COHN and SORALEE COHN, husband and wife ("Grantor"), in consideration of Ten Dollars (\$10.00) and other valuable consideration received from CHILDREN'S HOSPITAL, a Nebraska non-profit corporation ("Grantee"), conveys to Grantee the real estate legally described on Exhibit "A" attached hereto and by this reference made a part hereof (the "Real Estate").

Grantor covenants with Grantee that Grantor (i) is lawfully seized of the Real Estate and that it is free from all liens except real estate taxes not yet delinquent and subject only to those matters described on Exhibit "B" attached hereto; (ii) has legal power and lawful authority to convey the Real Estate; and (iii) warrants and will defend title to the Real Estate against the lawful claims of all persons.

Exhibit "A"

That part of the Northwest Quarter of the Northwest Quarter (NW¼NW¼) of Section 23, Township 15 North, Range 12 East of the 6th P.M., in the City of Omaha, in Douglas County, Nebraska, more particularly described as follows:

Beginning at a point 33 feet East of the West line of said Section 23 and 173.00 feet North of the North line of Block 1, Beverly Hills; thence North, along a line 33 feet East of and parallel to the West line of Section 23-15-12, for 7.1 feet; thence North 62E55" East, for 176.7 feet, to a point on the Southerly line of West Dodge Highway; thence South 56E11' East, along said Southerly line of West Dodge Street Highway, for 162.2 feet; thence South 33E13' West, for 160 feet; thence North 56E11' West, for 245.5 feet, more or less, to the Point of Beginning.
