EXHIBIT "A" TO UCC-1 FINANCING STATEMENT

All of the Debtor's right, title and interest in and to all Accounts, Merchandise, Inventory, Equipment, General Intangibles, Documents, Instruments, Chattel Paper (including but not limited to the Rental/Purchase Contract), Balances and Books and Record (collectively the "Collateral"), and all products and proceeds of the foregoing (including insurance proceeds):

As used herein, the following terms shall have the definitions set forth below:

- (I) Accounts mean any right of Debtor to payment for goods sold or leased or for services rendered which is not evidenced by an Instrument of Chattel Paper, whether or not earned by performance;
- (II) Balances mean all monies and funds of Debtor at any time on deposit with Secured Party;
- (III) Books and Record means the books and records of Debtor evidencing or relating to its businesses, financial conditions or the Collateral, including, but not limited to, all customer lists, ledgers, invoices, purchase orders, financial statements, computer tapes or disks;
- (IV) Chattel Paper shall have the meaning ascribed to it in the Code;
- (V) Code means the Uniform Commercial Code as adopted and in force in the State of Georgia;
- (VI) Documents shall have the meaning ascribed to it in the code;
- (VII) Equipment means all machinery, equipment, furniture, fixtures, motor vehicles and other tangible personal property (other than Inventory) of Debtor, including but not limited to, all items described on the Equipment Schedule (if attached) and all substitutions and replacements thereof;
- (VIII) General Intangibles shall have the meaning ascribed to it in the code and shall include, without limitation, all of Debtor's tax refund claims, patents, copyrights, licences, trademarks, trade names, service marks, patent application chooses and in action;
- (IX) <u>Instruments</u> shall have the meaning ascribed to it the code;
- (X) Inventory means all raw materials, work-in-process, finished goods, goods being leased pursuant to Rental/Purchase contracts, and other goods held by Debtor for sale or lease or furnished under contracts of service;
- (XI) Merchandise means goods distributed or sold to Debtor through Aaron Rents, Inc. and
- (XII) Rental/Purchase contracts means a contract between Debtor and a customer to rent Merchandise in the form approved by Aaron Rents, Inc. (and which may include purchase options).
