Plaintiff, Cindy J. McAtee, for her cause of action against the Defendant, states as follows:

- 1. Plaintiff is a resident of Douglas County, Nebraska.
- 2. Defendant, doing business as Bucky's Convenience Store, is a Nebraska corporation authorized to conduct business in Douglas County, Nebraska. All events referred to occurred at the premises located at 20402 Veterans Drive, Elkhorn, Douglas County, Nebraska, which premises is owned by Defendant.
- 3. On or about March 12, 2013, Plaintiff while inside the Bucky's Convenience Store, slipped and fell resulting in injuries and damages to the Plaintiff.
- 4. The injuries to the Plaintiff were the direct and proximate result of the negligence of the Defendant acting by and through its employees who, in turn, were acting in the scope and course of their employment.
- 5. As a direct and proximate result of the negligence of Defendant as aforesaid, Plaintiff sustained personal injuries resulting in physical and emotional pain and suffering and loss of enjoyment of life; that Plaintiff's injuries are permanent and she may reasonably be expected to suffer future physical and emotional pain and suffering and loss of enjoyment of life.
- 6. As a further direct and proximate result of the negligence of Defendant as aforesaid, Plaintiff incurred medical expenses as a result of the personal injury. Plaintiff

also anticipates that as a result of the permanent personal injuries she sustained, she may reasonably incur future medical expenses in the care of her injuries.

WHEREFORE, Plaintiff prays for a judgment against the Defendant for her special and general damages and her costs incurred.
