That part of the Southeast Quarter of Section 35, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Beginning at a point 100.0 feet West and 33.0 feet North of the Southeast corner of Section 35, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska; thence North 0°21'40" West along the West Right of Way of 72nd Street a distance of 150.0 feet; thence North 90°00'00" West along a line parallel with the North Right of Way of "F" Street, a distance of 170.0 feet; thence South 0°21'40" East on a line parallel with the West Right of Way line of 72nd Street, a distance of 150.0 feet; thence North 90°00'00" East along the North Right of Way line of "F" Street, a distance of 170.0 feet to a point of beginning
