AGREEMENT

THIS AGREEMENT is made and entered into by and between LAVIGNE ENTERPRISES and 3340 NORTH 33RD STREET, LLC, a Nebraska limited liability company, hereinafter called "Subdivider", whether one or more, and the CITY OF LINCOLN. NEBRASKA, a municipal corporation, hereinafter called "City"
