ORDER TO REOPEN ESTATE
AND RE-APPOINT A PERSONAL REPRESENTATIVE

Upon consideration of the Application to Reopen Estate and for Informal Appointment of a Personal Representative, the undersigned finds that:

1. The Application is complete.
2. The Applicant has made oath or affirmation that the statements contained in the Application are true to the best of Applicant's knowledge and belief.
3. The Applicant appears to be an interested person as defined in Nebraska Probate Code § 30-2209(21).
4. On basis of statements in the Application, venue is proper, and at least 120 hours have expired since the Decedent's death.
5. The Decedent's Will, dated March 28, 2006, was accepted for probate by this Court.
6. That Applicant and Jon Freiden previously were appointed as Co-Personal Representatives of the Decedent's estate in unsupervised administration.
7. That assets of the Estate, heretofore disclosed in the Inventory and included in the Inheritance Tax Determination, were not fully distributed by the previous Personal Representatives, and re-appointment of a Personal Representative is necessary to complete such distribution.
8. Applicant has nominated Joy Arnold, who is neither indebted to the estate nor a creditor of the estate, to be re-appointed as Personal Representative. The nominated person is qualified and whose status of priority is daughter to the Decedent.
9. No bond is required pursuant to the terms of the will.

WHEREFORE, the undersigned does hereby issue a Statement of Informal Probate reopening this Estate; that the above nominee be informally re-appointed as Personal Representative in unsupervised administration; and that new Letters shall be issued to said Personal Representative, who shall serve without bond.
