PERMANENT EASEMENT

Grainger, herein called the "GRANTOR", record owner of the real property hereinafter described, for and in consideration of the sum of One and 00/100 Dollars (\$1.00), duly paid, the receipt whereof is hereby acknowledged, and the further consideration of the performance of the covenants and agreements by GRANTEE as hereinafter set out and expressed does hereby GRANT, REMISE and RELINQUISH unto Lancaster County, Nebraska, herein called "GRANTEE" permanent easement on the following described real estate situated in Lancaster County, Nebraska, to wit:

A part of Lot 1, irregular tract in the SW¼ of Section 19, Township 9 North, Range 7 East of the 6th Principal Meridian, Lancaster County, Nebraska, more particularly described as follows:

Referring to the southwest corner of the said SW¼; thence easterly with the south line of the said SW¼, a distance of 1,189.37 feet; thence northerly perpendicular to the said south line, a distance of 50.00 feet to the point of beginning; thence northeasterly to a point located 1,439.37 feet easterly from the said southwest corner as measured with the said south line and 75.00 feet northerly from and measured perpendicular to the said south line; thence southeasterly to a point located 1,789.37 feet easterly from the said south west corner of the SW¼, as measured with the said south line and 50.00 feet northerly from and measured perpendicular to the said south line; thence westerly parallel with and 50.00 feet distant from the said south line of the SW¼, a distance of 600.00 feet to the point of beginning.

TO HAVE AND TO HOLD UNTO LANCASTER COUNTY, NEBRASKA, its successors and assigns, the right to construct, use and maintain on the land herein described utilities, such slopes as are necessary to retain and support the County road, the construction and/or extension of drainage structures and/or the construction of a drainage channel or drainage ditch and so long as such utilities, slopes, drainage structure, drainage channel or drainage ditch is used and maintained, the right of ingress and egress to said property herein described from the County road for the purpose of inspecting, repairing, and maintaining the said utilities, slopes, drainage structure, drainage channel and/or drainage ditch located thereon at the will of the GRANTEE, it being the intention of the parties hereto that the GRANTEE shall have the right to assign utility easements and that GRANTOR is hereby granting the uses herein specified without divesting GRANTOR of title and ownership of the rights to use the above described property for any purpose that does not interfere with the uses herein granted.
