1	WHEREAS, the United Presbyterian Welfare Foundation on behalf of the
2	Catholic Bishop of Lincoln has submitted an application designated as Special Permit No.
3	04013 for authority to construct a 148 unit domiciliary care facility on property generally
4	located at South 33rd Street and Yankee Hill Road, and legally described to wit:
5 6 7	Outlot F, Pine Lake Heights South 4th Addition, located in Section 19, Township 9 North, Range 7 East of the 6th P.M., Lancaster County, Nebraska;
. 8	WHEREAS, the Lincoln City-Lancaster County Planning Commission has
9	held a public hearing on said application; and
10	WHEREAS, the community as a whole, the surrounding neighborhood, and
11	the real property adjacent to the area included within the site plan for this domiciliary care
12	facility will not be adversely affected by granting such a permit; and
13	WHEREAS, said site plan together with the terms and conditions hereinafter
14	set forth are consistent with the comprehensive plan of the City of Lincoln and with the
15	intent and purpose of Title 27 of the Lincoln Municipal Code to promote the public health,
16	safety, and general welfare.
17	NOW, THEREFORE, BE IT RESOLVED by the Lincoln City-Lancaster
18	County Planning Commission of Lincoln, Nebraska:

Revise the grading plan to direct storm water via . 11 properly designed open channels or a storm sewer 12 pipe system to the existing 30' storm sewer stub at the 13 northwest corner of the lot. 14 ii. Revise the grading plan to show the correct grading for

- the Yankee Hill Road widening project to ensure the proposed site grading will match future right-of-way grades.
- iii. Revise the site plan, in accordance with an approved final plat, to show the dedication of the 33rd Street right-of-way and location of all public utilities abutting the site. The site plan must show and label South 33rd Street.

1				iv. Revise the site plan to show an outdoor recreation plan.
2				v. Revise the site plan to show LES easements.
3			b.	A final plat must be approved creating a buildable lot for this
4				project and dedicating the entire 33rd Street right-of-way

The Permittee shall sign and return the City's letter of acceptance to 3 4 the City Clerk within 30 days following approval of the special permit, provided, however, 5 said 30-day period may be extended up to six months by administrative amendment. The 6. City Clerk shall file a copy of the resolution approving the special permit and the letter of 7 acceptance with the Register of Deeds, filing fees therefor to be paid in advance by the Permittee. 8 9 The foregoing Resolution was approved by the Lincoln City-Lancaster County Planning Commission on this 14 day of April 10
