COME NOW the Defendants, Physicians Clinic, Inc. and The Nebraska Methodist Hospital, by and through their attorneys of record, and move the Court for an order setting and approving the amount of a supersedeas bond pursuant to Neb. Rev. Stat § 25-1916(1). In support of this Motion, Defendants state as follows:

1. On April 6, 2017, after a trial and jury verdict, the Court entered a Verdict Order and Judgment in favor of the Plaintiffs and against the Defendants in the following amounts:

\$1,750,000.00 in favor of Jackson Cuenca \$500,000.00 in favor of Emily Cuenca \$250,000.00 in favor of John Cuenca \$2,500,000.00 TOTAL

- 2. On April 10, 2017, Defendants filed their Notice of Appeal of the judgment to the Nebraska Court of Appeals and/or the Supreme Court of the State of Nebraska and paid the statutory docket fee and cash bond.
- 3. Defendants request an order from this Court establishing an amount certain for Defendants to post as Supersedeas during the pendency of Defendants' appeal.
- 4. Defendants propose to post a supersedeas bond written by a corporate surety company authorized to do business within the State of Nebraska, the same to be held firmly bound

unto Plaintiffs in the sum and in the amount of Two Million Six Hundred Thirty-Two Thousand Fifty and 00/100 Dollars (\$2,632,050.00). Defendants will prosecute such post-trial proceedings and appeal without delay and pay all money and costs which may be found against them on the final determination of said cause by the Appellate Courts of the State of Nebraska.

5. The proposed amount of \$2,632,050.00 is calculated as based upon estimating a two-year term (730 days) until resolution of the appeal with interest on the Judgment at 2.641%, which is the rate in effect on the date of Judgment. Further, if the appeal takes longer than the estimated two years, the undersigned Defendants agree to deposit or post additional funds or bond as necessary and as ordered by this Court, on or before April 10, 2019.
