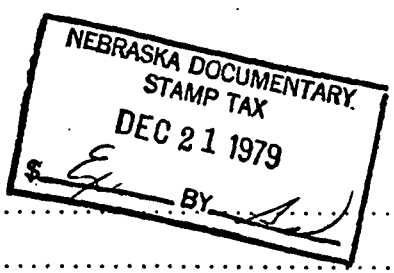

CORRECTIVE DEED

Grantee (whether one or more).

WHEREAS, the last Will of ... Willis Gene Farrington Deceased,
was duly admitted to probate in the County Court of ... Douglas County, Nebraska;

WHEREAS, Grantor was duly appointed Personal Representative of said estate and is now qualified and acting in said capacity;
and

WHEREAS, the Grantee is determined to be the person entitled to distribution of the hereinafter-described real property, and
Grantor is authorized to distribute the same to Grantee;

NOW, THEREFORE, Grantor conveys, assigns, transfers and releases to Grantee the following-described real property:

A tract of land in the Northeast 1/4, Section 10,
Township 15 North, Range 12 East of the 6th P.M.,
Douglas County, Nebraska, more particularly described
as follows: Commencing at the Southwest corner of
said Northeast 1/4; thence North 89° 57' 55" East
(an assumed bearing) along the South line of said
Northeast 1/4 for 378.0 feet; thence North for 183.0
feet to the point of beginning; thence South 89°
57' 55" West for 198.0 feet; thence North for 90.0
feet; thence North 89° 57' 12" East for 52.0 feet;
thence along a 148.45 foot radius curve to the left
(having a chord bearing North 75° 57' 30" East, for
71.80 feet) for an arc distance of 72.52 feet; thence
North 61° 57' 47" East for 20.46 feet; thence North
89° 57' 55" East for 58.28 feet; thence South for 117.0
feet to the point of beginning.

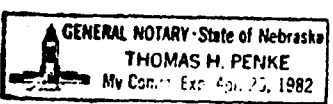
