did, on or about the 11th day of August , 1966 , execute to the State of Nebraska, for the consideration therein mentioned, a conveyance of the certain lands, situated in Douglas County, Nebraska and hereinafter more particularly described, which said conveyance is recorded in the office of the Register of Deeds of the County of Douglas , in Book 1360, Page 285, of the records of said office; and whereas in said conveyance, by mistake, the following was written:

in consideration of the agreement and consent of the State of Nebraska to the correction and of one dollar paid to it by the State of Nebraska, hereby grants, conveys, releases and confirms unto the State of Nebraska, their successors and assigns, forever, all of the following described tract of land situated in Douglas County, Nebraska, to wit:

A tract of land located in part of the West Half of the Northeast Quarter (more specifically defined as lying across the northerly part of the Northwest Quarter of the Northeast Quarter) of Section 4, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:
