

ORDINANCE NO. 374

AN ORDINANCE OF THE CITY OF WILBER, NEBRASKA, ANNEXING TO AND INCLUDING WITHIN THE CORPORATE LIMITS OF THE CITY OF WILBER, NEBRASKA, CONTIGUOUS AND ADJACENT LANDS, LOTS, TRACTS AND STREETS, BEING PORTIONS OF THE WEST HALF (W $\frac{1}{2}$) OF SECTION TWENTY-TWO (22), TOWNSHIP SIX NORTH (6N), RANGE FOUR (4) EAST OF THE 6TH P.M. IN SALINE COUNTY, NEBRASKA, SAID PORTIONS BEING URBAN AND SUBURBAN IN CHARACTER AND NOT AGRICULTURAL LANDS WHICH ARE RURAL IN CHARACTER, PROVIDING FOR THE FILING AND RECORDING OF A MAP OR PLAT OF THE AREA ANNEXED, AND PROOF OF PUBLICATION OF THIS ORDINANCE, REPEALING ANY ORDINANCES IN CONFLICT HEREWITH, AND PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, NEBRASKA:

SECTION 1. The following described lands, lots, tracts and streets located in the West Half (W $\frac{1}{2}$) of Section Twenty-two (22), Township Six North (6N), Range Four (4) East of the 6th P. M. in Saline County, Nebraska which are hereby found to be urban and suburban in character and not agricultural lands which are rural in character, and which are contiguous and adjacent to the present corporate limits of the City of Wilber, Nebraska, are hereby annexed to and included within the corporate limits of the City of Wilber, Nebraska:

Commencing at the North One-sixteenth (N $\frac{1}{16}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty-two (22), Township Six (6) North, Range Four (4), thence West (W) along the Section line Two hundred sixty-four feet (264'), thence South (S) Four hundred sixteen and five tenths feet (416.5'), thence East (E) parallel with the North (N) section line Two hundred sixty-four feet (264'), thence South (S) along the East (E) line of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) Two hundred forty-three and five tenths feet (243.5'), thence West One thousand three hundred twenty-four feet (1324'), thence South (S) along the Section line One thousand eight hundred eighty-one and four tenths feet (1881.4')

to the West Quarter corner of Section Twenty-two (22), Township Six North (6N), Range Four (4), thence East (E) along the South (S) side of the Northwest Quarter (NW $\frac{1}{4}$) One thousand three hundred twenty-three and seventy-eight hundredths feet (1323.78') to the Southeast (SE) corner of the Southwest Quarter (SW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$). Thence South (S) Four hundred sixty-two feet (462'), thence East (E) parallel with the North (N) line One Thousand and one hundred ninety-three and seventy-eight one-hundredths feet (1193.78') to the West (W) line of Highway Eighty-two (82), thence North (N) along the West (W) side of Highway Eighty-two (82) One thousand Five hundred eleven feet (1511') to the North (N) side of Ninth (9) street, thence West (W) along the North (N) side of Ninth (9) street One Thousand and Two hundred sixty and Twenty-eight hundredths feet (1260.28') to the West (W) line of the Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty-two (22), Township Six North (6N), Range Four (4), thence North (N) along the West (W) line of the East Half (E $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) to the place of beginning.

Section 2. Upon passage and publication of this Ordinance, as provided by law, the City Clerk shall file and cause to be recorded with the County Clerk of Saline County, Nebraska, an accurate map or plat of the territory annexed, as more particularly described in Section One hereof, certified by Carl Engel, Licensed Surveyor No. 35, and shall file and cause to be recorded with the County Clerk of Saline County, Nebraska, proof of publication of this Ordinance.

Section 3. All prior ordinances or portions thereof in conflict herewith are hereby repealed.

Section 4. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication as required by law.

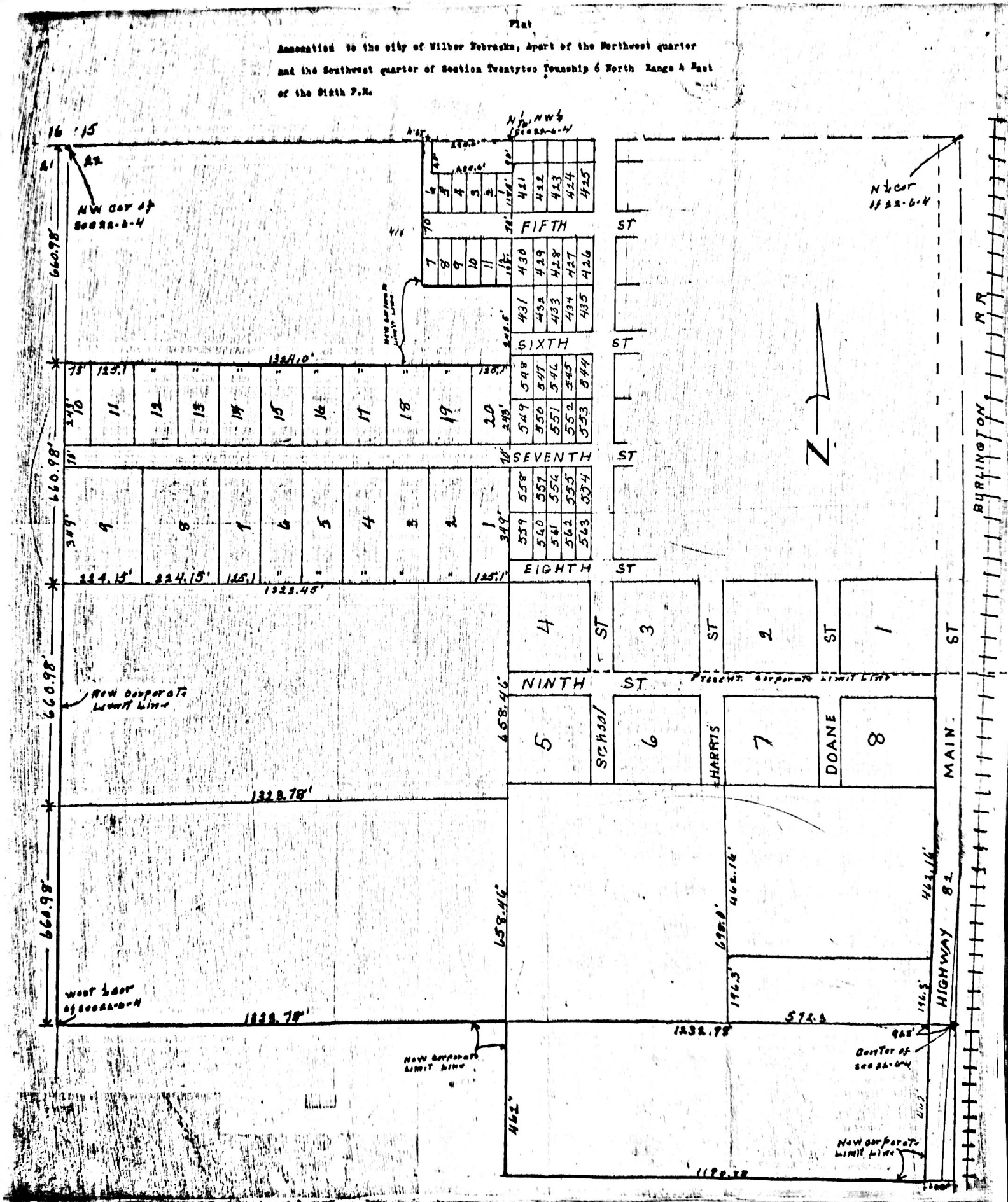
