

ORDINANCE NO. 24843

AN ORDINANCE vacating West 15' of 69th Street from North Property Line of Spring Street produced, to a point 15' North and 15' East of the North East Corner of Lot 1, Block 1, Lawn Field Addition in NW 1/4 NW 1/4 Section 36-15-12 in the City of Omaha and providing the effective date hereof.

WHEREAS, petition representing owners of more than 75 percent of the property abutting on West 15' of 69th Street from North Property Line of Spring Street produced, to a point 15' North and 15' East of the North East Corner of Lot 1, Block 1, Lawn Field Addition in NW 1/4 NW 1/4 Section 36-15-12 has been filed with the City of Omaha; and

WHEREAS, said property owners have in and by said petition waived any and all damages that may be occasioned by said vacation;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That West 15' of 69th Street from North Property Line of Spring Street produced, to a point 15' North and 15' East of the North East Corner of Lot 1, Block 1, Lawn Field Addition in NW 1/4 NW 1/4 Section 36-15-12 in the City of Omaha be, and is hereby, vacated; the vacating of the property herein described, and the reversal thereof, and that all utility reservations, including reservations usually granted to the City of Omaha, are hereby released.

Section 2. That this ORDINANCE shall take effect and be in force after 15 days from and after its passage.
