

CORRECTIVE *D.D.H.*
ORDINANCE NO. 2899

AN ORDINANCE OF THE CITY OF HASTINGS, NEBRASKA, PROVIDING FOR THE VACATION OF CERTAIN PLATTED EASEMENTS IN BLOCK ONE (1) OF HASTINGS INDUSTRIAL PARK WEST SUBDIVISION IN SAID CITY.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HASTINGS, NEBRASKA:

SECTION 1. That certain platted easements in Block One (1) of Hastings Industrial Park West Subdivision in the City of Hastings, Adams County, Nebraska, located as follows:

The railroad easements along the North Twenty-four Feet (N24') of Lots One (1) through Six (6), inclusive, and the South Twenty-four Feet (S24') of Lots Seven (7) through Twelve (12), inclusive; and

The utility easements along the West Ten Feet (W10') of Lot Three (3), the East Ten Feet (E10') and the West Ten Feet (W10') of Lot Four (4), the East Ten Feet (E10') and the West Ten Feet (W10') of Lot Five (5), the East Ten Feet (E10') of Lot Six (6), the West Ten Feet (W10') of Lot Ten (10), the East Ten Feet (E10') and the West Ten Feet (W10') of Lot Eleven, and the East Ten Feet (E10') of Lot Twelve (12), all in Block One (1), Hastings Industrial Park West, a subdivision of part of the Southeast Quarter (SE $\frac{1}{4}$) of Section Fourteen (14), Township Seven (7) North, Range Ten (10), West of the 6th P.M., in Adams County, Nebraska,


be and are hereby vacated. All public highways, streets, alleys, or other public grounds lying within said subdivision, not specifically referred to hereinabove, and which have not been heretofore released or vacated by action of this body, are being retained by the City of Hastings, Nebraska.

SECTION 2. A copy of this ordinance shall be, at the cost of the owner, certified to the office of the Register of Deeds of Adams County, Nebraska, and be there recorded by said owner.


SECTION 3. That any ordinance passed and approved prior to the passage, approval, and publication or posting of this ordinance, and in conflict with its provisions, is hereby repealed.

SECTION 4. Since an emergency exists, this ordinance shall take effect and be in full force upon the proclamation of the Mayor immediately upon its first publication.
