Two commercial entrances, not to exceed 40 feet in width, to provide ingress and egress to property of the owner, the centerlines of which are located 75.0 feet and 719.0 feet northerly from the South Line of the Southeast Quarter of the Northeast Quarter of Section 17, Township 8 North, Range 14 East of the 6th P.M., Otoe County, Nebraska, as measured along the centerline of the highway.
