ORDINANCE NO. 16366

01 AN ORDINANCE creating Sewer District No. 1148, providing for the
02 payments of the costs of the improvements constructed therein, designating the
03 property to be benefited, providing for the acquisition of easements and
04 additional right-of-way, if necessary, and repealing all ordinances or parts
05 of ordinances in conflict herewith.

06 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

07 Section 1. That Sewer District No. 1148 be and the same is hereby
08 created for the purpose of constructing an 8-inch diameter sanitary sewer or
09 sanitary sewers adjacent to the Burlington Northern Railroad located
10 approximately 1600 feet south of West 10¹ Street from Southwest 27th Street
11 west approximately 2,000 feet, in said City.

12 Section 2. Said district shall include the following described real
13 estate benefited, to-wit: The south 150.0 feet of Lots 65 and 94, both
14 Irregular Tracts located in the ~~Northwest~~ ^{Northeast} Quarter of Section 29, Township 10
15 North, Range 6 East of the 6th Principal Meridian; and including all that
16 portion of the west half of vacated Southwest 27th Street adjacent to the
17 south 150.0 feet of said Lot 94; located in the City of Lincoln, Lancaster
18 County, Nebraska.

19 Section 3. The cost of the construction of the sewers to accommodate
20 said district shall be assessed against the property in said district
21 benefited in proportion to the benefits, not exceeding the cost of said
22 sewers. In the event that easements or additional right-of-way must be
23 acquired for the completion of the proposed construction within this district,
24 such property rights may be acquired by negotiation and purchase or by
25 condemnation, if necessary, as provided by law.

01 Section 4. That all ordinances or parts of ordinances in conflict
02 herewith, be and the same hereby are repealed.

03 Section 5. This ordinance shall take effect and be in force from and
04 after its passage and publication according to law, but construction shall
05 not be commenced until ordered by resolution by the City Council.
