MEMORANDUM OF LEASE

Lessor by these premises does lease to Lessee, and Lessee does hereby accept the possession of the room or rooms described below and located on the real property and improvements consisting of 10 multi-housing units, located at 4015 & 4015 ½ Hamilton, Omaha, NE Lessor warrants and represents that only -0- units are plumbed with their own washer and/or dryer connections.
Lessor and Lessee have entered into an unrecorded lease containing the provisions included herein and certain additional provisions. The provisions of the unrecorded lease are incorporated herein by this reference. Lessor does hereby grant, convey and transfer to Lessee the exclusive use and possession of certain premises, described as encompassing approximately40 square feet for its use as a laundry facility (hereinafter referred to as the "Leased Premises").  2. The Lessee is hereby given a right of first refusal to meet any competitive bid(s) to continue providing laundry service, or for the purchase of laundry equipment by Lessor or its agent to serve the property in which the leased property is located, if this lease is not renewed or expired.
