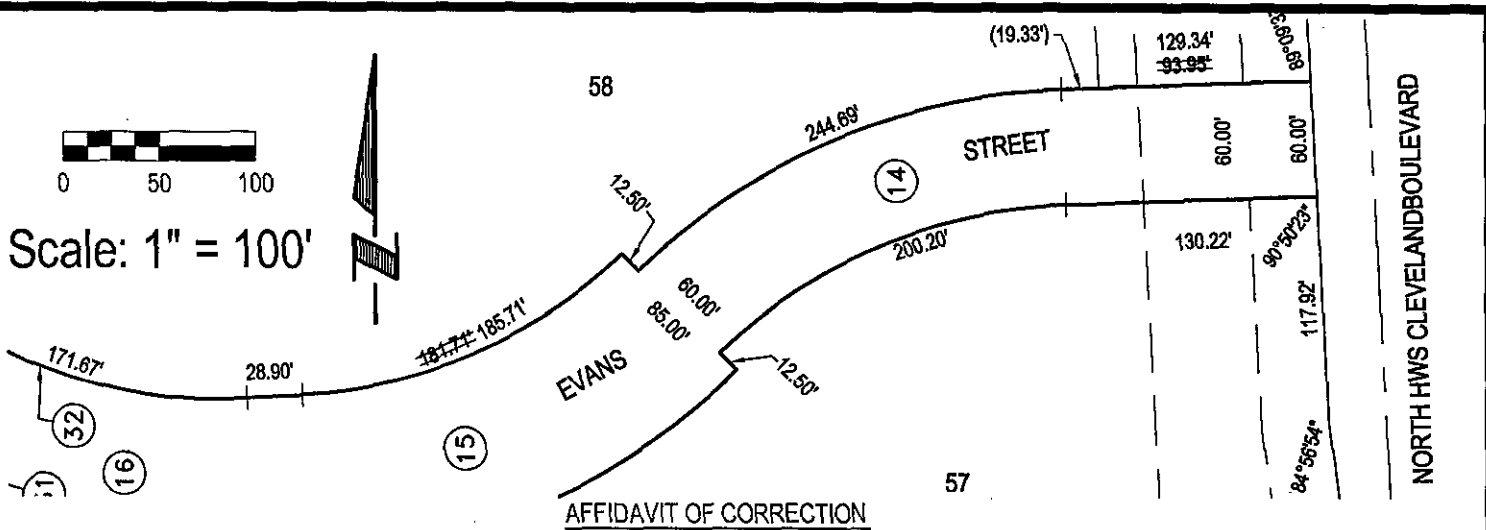

- The Northerly Right-of-way dimension of Evans Street to read 129.34 feet instead of 93.95 feet.

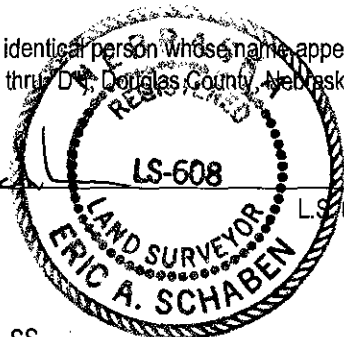
