- (A) City staff and consultants, as directed by the city administrator or an individual designated by the City Council, will check the construction plans of proposed improvements and report to the planning and zoning commission.
- Section 2: That Sections 17.80.040(F) and 17.84.030(D) of the City of New London, Iowa, Zoning Ordinance as codified in Chapter 17, Land Development Code, of the New London Municipal Code, are hereby deleted.
- Section 3: Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed
- Section 4: Saving Clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
- Section 5: When Effective: This Ordinance shall become effective immediately upon its final passage, approval and publication as provided by law.
