ASSIGNMENT OF EASEMENTS

KNOW ALL MEN BY THESE PRESENTS: That IOWA GAS COMPANY of the State of Iowa, a corporation organized and existing under the laws of the State of Iowa (hereinafter called "Iowa Gas"), in consideration of the sum of Ten Dollars (\$10.00) and of other good and valuable considerations in hand paid by IOWA PUBLIC SERVICE COMPANY of the State of Iowa, a corporation organized and existing under the laws of the State of Iowa (hereinafter called "IPS"), does hereby transfer, assign and convey unto the said IPS, its successors and assigns, all right, title and interest of Iowa Gas in and to those certain easements and right-of-way instruments described in the schedule attached hereto and made a part hereof entitled "Schedule of Right-of-Way Contracts Affecting Lands Situated in the County of Mills, State of Iowa," together with all of Iowa Gas's rights, title and interest in and to the lands described in the said easements and right-of-way instruments, the said lands being situated in the County of Mills, State of Iowa.

This Assignment of Easement is granted to IPS for recording purposes in furtherance of the corporate merger by and between IPS and Iowa Gas effective September 1, 1986. Taxation pursuant to Chapter 428A, Code of Iowa (1986) of real estate transfers is not imposed on instruments of transfer resulting from a corporate merger, nor on instruments transferring easements.

By the acceptance of delivery hereof, IPS assumes and agrees to perform all of the duties and conditions to be performed by Iowa Gas under said easements and right-of-way instruments commencing September 1, 1986.
