KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on the 3rd. day of March, 1941, ANNIE PETERS and FRED PETERS executed in favor of SOCONY-VACUUM OIL COMPANY, INC. a right of way agreement for pipe lines and other purposes covering, among other lands, the East Half (E $\frac{1}{2}$ ) of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Seventeen (17), Township Fourteen (14) North, Range Twelve (12) East, of the 6th. P. M., Sarpy County, Nebraska, said right of way agreement being recorded in Book 10 of the Miscellaneous Records, at Page 467, Sarpy County, Nebraska, reference to which is made for all purposes as if the same were copied herein; and

NOW, THEREFORE, in consideration of the premises, MAGNOLIA PIPE LINE COMPANY hereby releases all rights, privileges and easements held by it under the above mentioned right of way agreement, insofar and only insofar as it covers the East 200 Feet of the South 200 Feet of the North 233 Feet of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section 17, T14N, R12E, Sarpy County, Nebraska, but in all other respects and as to all other land covered by said agreement, the same shall remain in full force and effect.
