**DEDICATION AND REQUEST FOR ANNEXATION**

The foregoing subdivision of part of the Northwest Quarter of the Northwest Quarter of Section 22, Township 6 North, Range 4 East of the 6th P.M. Saline County, Nebraska, more particularly described as follows:

Commencing at the Northeast Corner of the Northwest Quarter of the Northwest Quarter of said Section 22 thence west along the north line of the Northwest Quarter of the Northwest Quarter of Section 22 a distance of 264.0 feet to the point of beginning, thence continuing west along the north line of the Northwest Quarter of the Northwest Quarter of Section 22 a distance of 504.0 feet, thence south parallel with the west line of Kenneth Kreshel's First and Second Addition's to the City of Wilber a distance of 208.5 feet, thence west parallel with the north line of the Northwest Quarter of the Northwest Quarter of Section 22 a distance of 70.0 feet, thence south parallel with the west line of Kenneth Kreshel's First and Second Additions to the City of Wilber a distance of 347.5 feet, thence west a distance of 37.7 feet, thence south a distance of 104.0 feet to the Northeast Corner of Lot 13, Pospisil's Addition to the City of Wilber, thence east a distance of 611.7 feet along the north line of Pospisil's Addition to the City of Wilber to the west line of Kenneth Kreshel's Second Addition to the City of Wilber, thence north along the west line of Kenneth Kreshel's Second and First Additions to the City of Wilber a distance of 660.0 feet to the point of beginning, containing 8.28 acres more or less and the platting of the same as Kenneth Kreshel's Third Addition to the City of Wilber, Saline County Nebraska is made with the free consent and in accordance with the desires of the undersigned owners and proprietors. 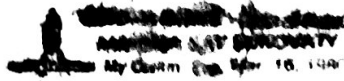
