## **ORDINANCE NO. 351**

AN ORDINANCE OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA, AN-NEXING TO AND INCLUDING WITHIN THE CORPORATE LIMITS OF THE CITY OF WILBER, SALINE COUNTY, CONTIGUOUS NEBRASKA, AND ADJACENT LANDS, LOTS, TRACTS AND AND STREETS. KNOWN KRESHEL'S KENNETH THIRD ADDITION TO THE CITY OF WILBER, SALINE COUNTY, NEBRASKA, BEING A PORTION OF THE NORTHWEST QUARTER OF THE NORTH-WEST QUAR-TER (NW14NW14) OF SECTION TWENTY-TWO (22), IN TOWNSHIP SIX (6) NORTH, RANGE FOUR (4), EAST OF THE 67H P.M. IN SALINE COUNTY, NEBRASKA, SAID PORTION BEING URBAN SUBURBAN CHARACTER AND AGRICULTURAL LANDS WHICH ARE RURAL IN CHARACTER; PROVIDING FOR THE FILING AND RECORDING OF A MAP OR PLAT OF THE AREA ANNEXED, AND PROOF OF PUBLICATION OF THIS OF TH **PROVIDING** ORDINANCE; ORDINANCE; PROVIDING

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, S A L I N E C O U N T Y, NEBRASKA:

SECTION 1. That the following described lands, lots, tracts and streets, known as Kenneth Kreshel's Third Addition to the City of Wilber, Saline County, Nebraska, located in the Northwest Quarter of the Northwest Quarter (NW14NW14) of Section Twenty-two (22), in Township Six (6) North, Range Four (4), East of the 6th P.M. in Saline County, Nebraska, which are hereby found to be urban and suburban in character and not agricultural lands which are rural in character, and which are contiguous and adjacent to the present corporate limits of the City of Wilber, Saline County, Nebraska, are hereby annexed to and included within the corporate limits of the City of Wilber, Saline County, Nebraska, to-wit:

Commencing at the Northeast Corner of the Northwest Quarter of the Northwest Quarter of said Section 22 thence west along the north line of the Northwest Quarter of the Northwest Quarter of Section 22 a distance of 264.0 feet to the point of beginning, thence continuing west along the north line of the Northwest Quarter of the

Northwest Quarter of Section 22 a distance of 504.0 feet, thence south parallel with the west line of Kenneth Kreshel's First and Second Additions to the City of Wilber a distance of 208.5 feet, thence west parallel with the north line of the Northwest Quarter of the Northwest Quarter of Section 22 a distance of 70.0 feet, thence south parallel with the west line of Kenneth Kreshel's First and Second Additions to the City of Wilber a distance of 347.5 feet, thence west a distance of 37.7 feet, thence south a distance of 104.0 feet to the Northeast Corner of Lot 13, Pospisil's Addition to the City of Wilber, thence east a distance of 611.7 feet along the north line of Pospisil's Addition to the City of Wilber to the west line of Kenneth Kreshel's Second Addition to the City of Wilber, thence north along the west line of Kenneth Kreshel's Second and First Additions to the City of Wilber a distance of 660.0 feet to the point of beginning, containing


