STANDARD OIL COMPANY, an Indiana corporation, with its principal office at 910 South Michigan Avenue, Chicago, Illinois, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to it in hand paid by THE AMERICAN OIL COMPANY, a Maryland corporation, with its principal office at 910 South Michigan Avenue, Chicago, Illinois, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell, transfer, convey and assign unto the said THE AMERICAN OIL COMPANY all of STANDARD OIL COMPANY's rights, titles and interests in, to and under those certain right of way instruments described in the schedule attached hereto and made a part hereof entitled "SCHEDULE OF RIGHT OF WAY CONTRACTS AFFECTING LANDS SITUATED IN THE COUNTY OF POTTAWATTAMIE, STATE OF IOWA", together with all of STANDARD OIL COMPANY's rights, titles and interests in and to the lands described in the said right of way instruments, the said lands being situated in the County of Pottawattamie, State of Iowa.
