Pursuant to a written stipulation heretofore entered into by and between the parties, the Court does hereby order, adjudge and decree as follows:

I.

Judgment is entered for the Plaintiffs, and against the Defendant, in the amount of Eight Thousand Dollars (\$8000.00) without interest thereon; that said sum shall constitute the full and just compensation due and owing the Plaintiffs by reason of the condemnation proceeding brought by the Defendant, against the Plaintiffs, before the County Judge of Sarpy County, Nebraska.

II.

That the stipulation described in the condemnation proceeding filed before the County Judge of Sarpy County, Nebraska, is hereby affirmed, and in addition thereto, there shall be an additional commercial entrance not to exceed 40 feet in width, said drive to be located approximately 535 feet south of the quarter line of Section 23, Township 14 North, Range 12 East of Sarpy County, Nebraska, as measured along the West line of said section.

III.

That the cost in this Court including the cost to be incurred in certifying a copy of this Order to the County Judge of Sarpy County, Nebraska, be taxed to the Defendant.

IV.

That a copy of this Order be certified by the Clerk of the District Court of Sarpy County, Nebraska, to the Register of Deeds and to the County Judge of Sarpy County, Nebraska; and that said County Judge is hereby authorized and directed to make payment to the Plaintiffs in the sum of Eight Thousand Dollars (\$8000.00)

from the funds heretofore deposited with said County Judge by the Defendant, and to return the balance of said funds, if any, to the Defendant; and said Register of Deeds is hereby directed to file said copy in the records pertaining to the property previously described.

That upon performance of said acts, the County Judge of Sarpy County, Nebraska, is hereby directed to notify the Clerk of the District Court of Sarpy County, Nebraska, that disbursement of the funds has been made according to this Order of Court, and such notification of the payment of the sum of Eight Thousand Dollars (\$8000.00) shall be entered by the Clerk of the District Court of Sarpy County, Nebraska, as satisfaction of the judgment.
