## MEMORANDUM OF AGREEMENT (NEBRASKA)

PLEASE TAKE NOTICE that Broadmoor Management Company, as agent for "Owner"/Colonial Park Apartments, and CoxCom,Inc. d/b/a Cox Communications Omaha, Inc., a Nebraska corporation ("Cox Communications") have entered into a Telecommunications Services Agreement ("Agreement") dated February 1,1999, which, in accordance with its terms, entitles Cox Communications to provide cable television services throughout the property described on Exhibit A attached hereto and incorporated herein by this reference. Among other things, the Agreement provides Cox Communications with rights of ingress and egress to the property necessary or useful to provide such service and maintain its facilities on the property used in providing such services.
