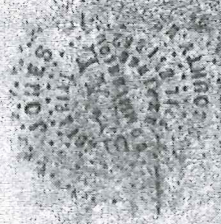
Beginning at the north quarter corner of said Section 9; thence easterly on the North line of the Northeast Quarter of said Section 9 a distance of 1,319.0 feet to the northeast property corner; thence southerly on the East property line a distance of 80.0 feet; thence westerly a distance of 1245.7 feet to a point 90.0 feet southerly from said North line; thence northwesterly a distance of 103.5 feet to a point on the West line of said Northeast Quarter; thence northerly on said West line a distance of 16.8 feet to the point of beginning, containing 2.52 acres, more or less, which includes 1.00 acre, more or less, previously occupied as a public highway, the remaining 1.52 acres, more or less, being the additional acreage hereby secured.

Also a tract of land located in the East Half of the Southeast Quarter of Section 4, Township 17 North, Range 5 East of the 6th P.M., Dodge County, Nebraska, described as follows:

Beginning at the south quarter-quarter corner in the Southeast Quarter of said Section 4; thence easterly on the South line of the East Half of the Southeast Quarter of said Section 4 a distance of 1,019.5 feet; thence westerly on an 1,065.86 foot radius curve to the left (initial tangent of which forms an angle of 165 degrees 56 minutes left with said South line) a distance of 457.4 feet to point of tangency; thence continuing westerly, tangent a distance of 537.0 feet to a point on the West line of said East Half of the Southeast Quarter; thence southerly on said West line a distance of 80.0 feet to the point of beginning, containing 1.17 acres, more or less, which includes 0.70 acre, more or less, previously occupied as a public highway, the remaining 0.47 acre, more or less, being the additional acreage
