The Mayor and Council of the City of Friend, Nebraska (the "City") met in special session at the City Hall on the 20<sup>th</sup> day of December, 2001, at 5:00 p.m., in a publicly convened session, the same being open to the public and having been preceded by advance publicized notice thereof by posting the same in three public places in the City, as evidenced by Attachment #1, said form of notice being the designated method for giving notice. Advance notice of the meeting was also given to the Mayor and City Council Members and a copy of their acknowledgment of receipt of such notice is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and City Council members. All proceedings hereafter shown were taken while the meeting was open to attendance of the public.

The Mayor, James Vossler, presided, and the City Clerk, Rhonda Bulwan recorded the proceedings. The following Council Members were present: Roger Horner, Gary Tuttle and Dan Fricke. Absent: Rhonda Bulwan. A quorum being present and the meeting duly convened, the following proceedings were had and done.

The Mayor stated that one of the purposes of the meeting was to consider the creation of certain street improvement districts and gap paving projects and to transact such other business as may properly come before the Council.

Council Member Dan Fricke introduced an ordinance entitled:

## ORDINANCE NO. 01-573

AN ORDINANCE OF THE CITY OF FRIEND, NEBRASKA CREATING STREET IMPROVEMENT DISTRICT NOS. 2001-1 AND 2001-2; DEFINING THE SAME AND THE LIMITS THEREOF; PROVIDING FOR PAVING, GRADING, CURBING AND GUTTERING, OR SUCH OTHER WORK AS IS NECESSARY AND INCIDENTAL THERETO; PROVIDING FOR PLANS, SPECIFICATIONS, ESTIMATES OF COST AND SECURING OF BIDS; PROVIDING FOR THE PAYMENT OF SUCH WORK AND OTHER EXPENSES INCIDENTAL THERETO; PROVIDING FOR ASSESSMENT OF THE COST OF SAID IMPROVEMENTS AGAINST THE PROPERTY IN SAID DISTRICTS ESPECIALLY BENEFITED THEREBY IN PROPORTION TO SAID BENEFITS; PROVIDING FOR THE ISSUANCE OF DISTRICT IMPROVEMENT WARRANTS AND DISTRICT AND INTERSECTION IMPROVEMENT BONDS AND FOR THE LEVY OF SPECIAL ASSESSMENTS AND GENERAL TAXES TO PAY FOR SAID IMPROVEMENTS; AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM AND THE TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.

Council Member Gary Tuttle moved that the statutory rule requiring that ordinances be read by title on three different days be dispensed with so that Ordinance No. 01-573 might be introduced, read by title and then moved for final passage on the same day, without the same being read in full, which motion was seconded by Council Member Roger Horner. The yeas and nays were called and the vote was as follows: "YEA": Dan Fricke, Gary Tuttle and Roger Horner. "NAY": none. Absent or not voting: Rhonda Bulwan. The motion to suspend the statutory rule, having been agreed upon by three-fourths (3/4) of the Members of the City Council present and acting, was by the Mayor declared passed and adopted.

Following the reading of the title of said ordinance, Council Member Dan Fricke then moved that said ordinance be passed, which motion was seconded by Council Member Roger Horner. The Mayor then stated, "The question is, shall Ordinance No. 01-573 be passed and adopted?" The yeas and nays were called, the vote being as follows: "YEA": Gary Tuttle, Roger Horner and Dan Fricke. "NAY": none. Absent or not voting: Rhonda Bulwan. The passage and adoption of said ordinance having been agreed upon by a majority of all of the Members elected to the City Council, the Mayor declared the ordinance passed and adopted and, in the presence of the City Council, signed and approved said ordinance and the City Clerk attested its passage and approval and affixed his signature and the seal of the City thereto.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, NEBRASKA:

Section 1. Street Improvement District No. 2001-1 ("District No. 2001-1") of the City of Friend, Nebraska (the "City") is hereby created pursuant to Sections 17-509, *et seq.*, Reissue Revised Statutes of Nebraska, as amended.

Section 2. District No. 2001-1 shall include and encompass the designated portions of the following streets in the City and the limits, boundaries and improvements are defined and established as follows:

STREET IMPROVEMENT DISTRICT NO. 2001-1

THE STREET TO BE IMPROVED BY PAVING, GRADING, CURBING AND GUTTERING, DRAINAGE AND STORM SEWER, AND INCIDENTAL WORK CONNECTED THEREWITH IS:

Page Street from First Street to Fifth Street  
Fifth Street from Race Street to Page Street

THE PROPERTY TO BE INCLUDED IN THE DISTRICT CONSISTS OF THE AREA DESCRIBED AS FOLLOWS:

Section 5. The City's special engineers with respect to District No. 2001-1, Speece & Lewis Engineers, Lincoln Nebraska, shall make detailed plans and specifications for said improvements in District No. 2001-1 and an estimate of the cost thereof, and shall submit the same to the City Council. The City's special engineers with respect to District No. 2001-2, Kirkham Michael Consulting Engineers, Omaha Nebraska, shall make detailed plans and specifications for said improvements in District No. 2001-2 and an estimate of the cost thereof, and shall submit the same to the City Council. Upon approval of the same by the City Council, bids for construction of said work shall be provided by advertisement. On acceptance of any bid therefor, the Mayor and City Clerk are authorized to enter into a contract on behalf of the City for such work, and such contract shall be executed by said Mayor and attested by said City Clerk. The City Council shall have and hereby reserves the right to reject any and all bids received.

Section 6. The work and improvements in each District shall be made at public cost, but special assessments on the properties especially benefitted thereby shall be levied to reimburse the City to the extent provided by law.

Section 7. For the purpose of paying for the paving, grading, curbing and guttering, sidewalks, drainage and storm sewer, or such other necessary improvements incidental thereto, the Mayor and City Council may issue district improvement warrants or bond anticipation notes of the City in the form and manner provided by law.

Section 8. To effect the final payment and retirement of said warrants and bond anticipation notes, and to pay for the cost of paving, grading, curbing and guttering,




sidewalks, drainage and storm sewer, or other necessary improvements incidental thereto, the Mayor and City Council shall issue bonds in the form and manner provided by law.

Section 9. After the passage and publication of this ordinance as in Section 10 provided, there shall be published at least once each week for not less than twenty (20) days, as provided by law, in the Friend Sentinel, a newspaper of general circulation in the City, a notice with respect to each District created by the terms of this ordinance, which notice shall provide, among other things, that if owners of record title representing more than fifty percent (50%) of the front footage of the property directly abutting on the street, streets, alley or alleys to be improved in said District shall file with the City Clerk within twenty (20) days after the first publication of said Notice, written objections to the creation of such District, the improvements in such District shall not be made as provided in this ordinance.

Section 10. This ordinance shall be published in pamphlet form, and in the form and manner provided by law, and shall take effect and be in full force from and after its passage, approval and publication as provided by law.

Street Improvement Project No. 2001-1 ("Project No. 2001-1") of the City of Friend, Nebraska (the "City") is hereby created pursuant to the Gap Act and shall include and encompass the designated portions of the following streets in the City and the limits, boundaries and improvements are defined and established as follows:

THE STREET TO BE IMPROVED BY PAVING, GRADING, CURBING AND GUTTERING, DRAINAGE AND STORM SEWER, AND INCIDENTAL WORK CONNECTED THEREWITH IS:

Vine Street from Second Street to Third Street

THE PROPERTY TO BE INCLUDED IN THE PROJECT CONSISTS OF THE AREA DESCRIBED AS FOLLOWS:

A tract of land located in to the City of Friend, Saline County, Nebraska, described as follows:

Beginning at the northwest corner of Lot 3, Block 2, Ainsworth First Addition, City of Friend, Saline County, Nebraska; thence easterly to the northeast corner of Lot 5, Block 1, Ainsworth First Addition, City of Friend, Saline County, Nebraska; thence southerly to the southeast corner of Lot 10, Block 1, Ainsworth First Addition, City of Friend, Saline County, Nebraska; thence westerly to the southwest corner of Lot 8, Block 2, Ainsworth First Addition, City of Friend, Saline County, Nebraska; thence northerly to the point of beginning.

THE FOLLOWING PARCELS OF LAND ARE INCLUDED IN SAID DISTRICT AND ARE SUBJECT TO ASSESSMENT:

Lots 5,6,7,8,9 and 10, Block 1, Ainsworth First Addition, City of Friend, Saline County, Nebraska;

Lots 1,2,3,8,9 and 10, Block 2, Ainsworth First Addition, City of Friend, Saline County, Nebraska;

Section 5. The Mayor and City Council hereby find and determined that: (a) Sixth Street from Cherry Street to Spring Street is not paved; (b) paving Sixth Street from Cherry Street to Spring Street would make one continuous paved street; (c) the portion of Sixth Street to be so improved does not exceed two blocks including intersections or thirteen hundred twenty-five feet, whichever is less; and (d) it is necessary, desirable, advisable and in the best interest of the City that Sixth Street be paved from Cherry Street to Spring Street in accordance with the provisions of the Gap Act.

Section 6. Street Improvement Project No. 2001-3 ("Project No. 2001-3") of the City of Friend, Nebraska (the "City") is hereby created pursuant to the Gap Act and shall include and encompass the designated portions of the following streets in the City and the limits, boundaries and improvements are defined and established as follows:

STREET IMPROVEMENT PROJECT NO. 2001-3

THE STREET TO BE IMPROVED BY PAVING, GRADING, CURBING AND GUTTERING, DRAINAGE AND STORM SEWER, AND INCIDENTAL WORK CONNECTED THEREWITH IS:

Sixth Street from Cherry Street to Spring Street

THE PROPERTY TO BE INCLUDED IN THE DISTRICT CONSISTS OF THE AREA DESCRIBED AS FOLLOWS:

A tract of land located in the City of Friend, Saline County, Nebraska, described as follows:

Beginning at the northwest corner of Lot 22, L.E. Southwick's Addition, City of Friend, Saline County, Nebraska; thence easterly to the northeast corner of Lot 17, L.E. Southwick's Addition, City of Friend, Saline County, Nebraska; thence southerly to the southeast corner of Lot 28, L.E. Southwick's Addition, City of Friend, Saline County, Nebraska; thence westerly to the southwest corner of Lot 45, L.E. Southwick's Addition, City of Friend, Saline County, Nebraska; thence northerly to the point of beginning.

THE FOLLOWING PARCELS OF LAND ARE INCLUDED IN SAID DISTRICT AND ARE SUBJECT TO ASSESSMENT:

Lots 117,18,19,20,21,22,26,27,28,45,46 and 47, L.E. Southwick's Addition, City of Friend, Saline County, Nebraska

Section 7. The City's special engineers, Kirkham Michaels Consulting Engineers Omaha Nebraska, shall make detailed plans and specifications for said improvements in Project Nos. 2001-1, 2001-2 and 2001-3 and an estimate of the cost thereof, and shall submit the same to the City Council. Upon approval of the same by the City Council, bids for construction of said work shall be provided by advertisement. On acceptance of any bid therefor, the Mayor and City Clerk are authorized to enter into a contract on behalf of the City for such work, and such contract shall be executed by said Mayor and attested by said City Clerk. The City Council shall have and hereby reserves the right to reject any and all bids received.

Section 8. The work and improvements in each District shall be made at public cost, but special assessments on the properties especially benefitted thereby shall be levied to reimburse the City to the extent provided by law.

Section 9. For the purpose of paying for the paving, grading, curbing and guttering, sidewalks, drainage and storm sewer, or such other necessary improvements incidental thereto, the Mayor and City Council may issue district improvement warrants or bond anticipation notes of the City in the form and manner provided by law.

Section 10. To effect the final payment and retirement of said warrants and bond anticipation notes, and to pay for the cost of paving, grading, curbing and guttering, sidewalks, drainage and storm sewer, or other necessary improvements incidental thereto, the Mayor and City Council shall issue bonds in the form and manner provided by law.
