CONVEYANCE AND ASSIGNMENT OF EASEMENTS,

LICENSES, PERMITS AND LEASES

THIS CONVEYANCE AND ASSIGNMENT OF EASEMENTS, LICENSES, PERMITS AND LEASES (this "Assignment") is executed on this 4th day of October, 2007, but made effective as of 7:00 AM Central Time on the 5th day of October, 2007 (the "Effective Time") by and among KINDER MORGAN OPERATING L.P. "A", a Delaware limited partnership with an address of 500 Dallas, Suite 1000, Houston, Texas 77002 (formerly known as Hydrocarbon Transportation, Inc., Northern Gas Products Co. and Enron Liquids Pipeline Operating Limited Partnership) ("ASSIGNOR") and ONEOK NORTH SYSTEM, L.L.C., a Delaware limited liability company with an address of 100 West 5th Street, Tulsa, Oklahoma, 74103 ("ASSIGNEE"). This Assignment is made pursuant to that certain Purchase and Sale Agreement (the "Purchase Agreement") dated as of June 29, 2007 by and between Assignor and ONEOK Partners Intermediate Limited Partnership. Unless otherwise defined herein, all capitalized terms used herein shall have the same meanings attributed to them as are set forth in the Purchase Agreement.

1. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and confessed, ASSIGNOR hereby grants, bargains, conveys, delivers, assigns, and transfers to ASSIGNEE, effective as of the Effective Time, regardless of the date of execution, all of ASSIGNOR's right, title and interest in and to, together with all privileges appurtenant thereto, including, but not limited to, all fixtures, pipelines and improvements located thereon, the Easements, Permits, leases and other assets listed and more particularly described on "Exhibit A" attached hereto and made a part hereof (the "Subject Assets").

TO HAVE AND TO HOLD the Subject Assets unto ASSIGNEE, its successors and assigns forever.

2. This Assignment is being executed in connection with, and is subject to the terms, conditions, representations and warranties set forth in, the Purchase Agreement and shall neither add to nor detract from the rights of the parties under the Purchase Agreement.

3. Assignee hereby expressly assumes and agrees to pay, discharge and perform, in accordance with their terms, all liabilities of Assignor under the instruments creating the Subject Assets, excluding the Retained Liabilities.

4. This Assignment shall be binding upon and inure to the benefit of the respective designees, successors and permitted assigns of the ASSIGNOR and ASSIGNEE, and may be executed

in a number of identical counterparts, each of which for all purposes is to be deemed as original, and all of which constitute, collectively, one instrument.

5. This Assignment shall be governed by and construed in accordance with the laws of the state in which the Subject Assets are located.

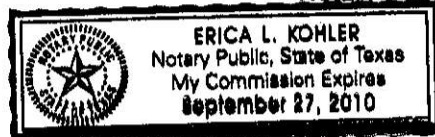

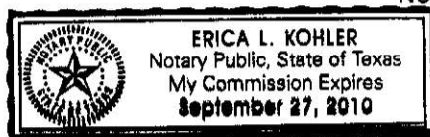
