



That part of Lot 1, Block 1, Replat of Green Valleys, an Addition to the City of Omaha, Douglas County, Nebraska, more particularly described as follows: Beginning at a point on the East line of said Lot 1 that is 34.10 feet Southerly of the Northeasterly corner of said Lot 1; Thence S9°57'10"W (assumed bearing) for 96.85 feet along the Easterly line of said Lot 1; Thence along a curve to the right (having a radius of 356.52 feet and a long chord bearing S20°25'56"W for 129.69 feet) an Arc distance of 130.42 feet; Thence N57°22'10"W for 159.93 feet; Thence North for 51.45 feet; Thence West for 21.0 feet; Thence North for 39.00 feet to the Northerly line of said Lot 1; Thence N69°14'10"E for 21.16 feet along said Northerly line; Thence N25°19'30"E for 81.35 feet along the Westerly line of said Lot 1; Thence S75°57'30"E for 168.15 feet along a line parallel with and 34.08 feet Southerly of the Northerly line of said Lot 1, to the point of beginning.
