RESOLVED,

WHEREAS the plat of Green Valleys, an Addition to The City of Omaha, as surveyed, platted, and recorded in Douglas County, Nebraska, was approved and accepted by the City Council on October 21, A.D., 1947; and,

WHEREAS William Parkinson Inc., Omaha Industrial Housing Corporation, Valley Realty Company, and Frederick Realty Company are the owners of all of the lots and lands except streets and alleys embraced and included in the said Green Valleys; and,

WHEREAS the said owners desire to vacate the following lots and blocks in Green Valleys:

All Lots 1 to 14 both inclusive, Block 1; the East 25 feet of Lot 21, all of Lots 22 to 39 both inclusive, Block 2; and the parts of Lots 40, 41, and 42, Block 2, lying East of a line 120 feet East of and parallel to the East line of 42nd Street; and also that part of Lot 14, Block 3 lying East of a line 135.8 feet East of and parallel to the East line of 43rd Street; all of Lots 15 to 27 both inclusive, Block 3, and the East 26 feet of Lot 28, Block 3.

for the purpose of replatting the land embraced in the said plat and subdivision and have presented a petition praying for vacation to the City Council, which is Document No. 4456, current series, and have submitted therewith a proposed replat of Green Valleys, which is denominated

"Replat of Block 1, Green Valleys, the Replat of the East part of Block 2, Green Valleys, the Replat of the East part of Block 3, Green Valleys, and the Filing Plat of Blocks 4, 5, 6, 7, and 8 and Lot 1, Block 10, and Lot 1, Block 11, Green Valleys".

which plat has been approved by the City Engineer of The City of Omaha on June 20, A.D., 1949; and,

WHEREAS owners of the property abutting on the streets and alleys in the part of the plat and subdivision of Green Valleys proposed to be vacated have waived all claims for compensation or damages by reason of the vacating.
