PETITION FOR VACATION OF STREETS AND LOTS

Omaha, Nebraska

September 21, 1949

TO THE HONORABLE MAYOR AND CITY COUNCIL
OF THE CITY OF OMAHA, NEBRASKA

Gentlemen:

We, WILLIAM PARKINSON, INC., OMAHA INDUSTRIAL HOUSING CORPORATION, VALLEY REALTY COMPANY and FREDERICK REALTY COMPANY, hereby petition your honorable body to vacate all streets dedicated to the public in the filing plat of Green Valleys in 1947, and approved and accepted by the City Council of the City of Omaha, Nebraska on October 21st, A.D., 1947, except the

West 300 feet of Grover Street, the West 150 feet of Valley Street and Frederick Street between 41st and 42nd Streets.

We hereby certify that we own all property abutting on the Streets where vacations are requested, and we each hereby waive any and all claim for compensation or damages should this Petition be approved. We request that this vacation be made in accordance with Chapter 14-115 Revised Statutes of Nebraska 1943.

We also request that the following lots in Green Valleys be vacated for replatting:

All Lots 1 to 14 both inclusive, Block 1; the East 25 feet of Lot 21, all of Lots 22 to 39 both inclusive, Block 2; and the parts of Lots 40, 41 and 42, Block 2, lying East of a line 120 feet East of and parallel to the East line of 42nd Street; and also that part of Lot 14, Block 3 lying East of a line 135.5 feet East of and parallel to the East line of 42nd Street; all of Lots 15 to 27 both inclusive, Block 3, and the East 25 feet of Lot 28, Block 3.

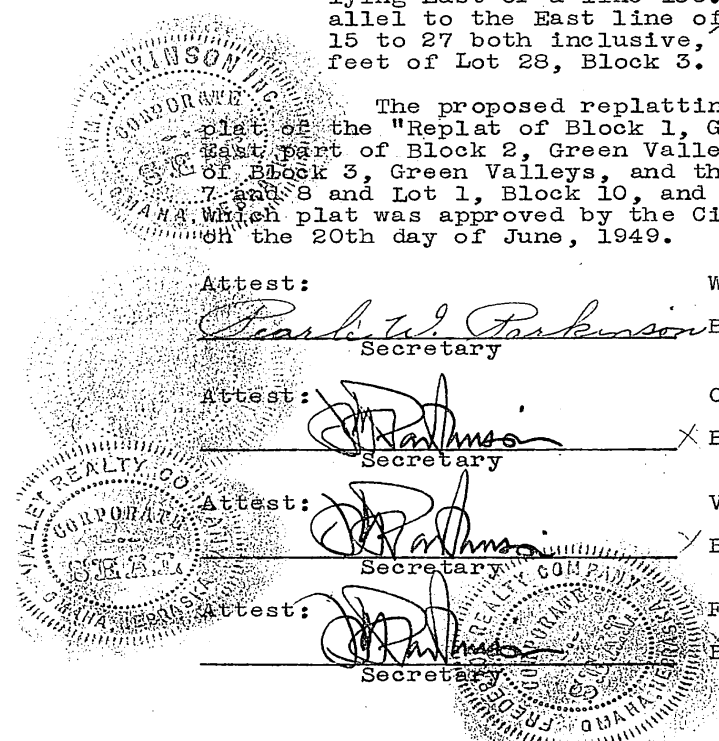
The proposed replatting of this property is shown on plat of the "Replat of Block 1, Green Valleys, the Replat of the East part of Block 2, Green Valleys, the Replat of the East part of Block 3, Green Valleys, and the Filing Plat of Blocks 4, 5, 6, 7, and 8 and Lot 1, Block 10, and Lot 1, Block 11, Green Valleys", which plat was approved by the City Engineer for the City of Omaha on the 20th day of June, 1949.

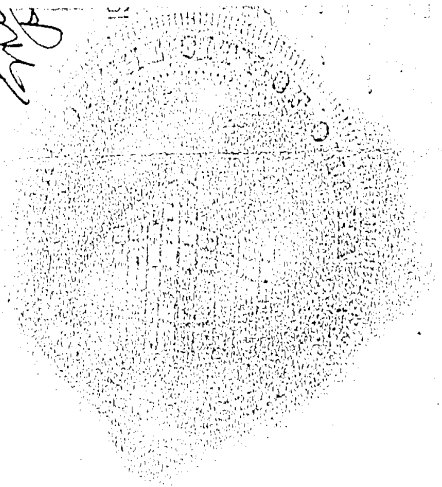
