Releasing a strip of land Ten (10) feet in width being Five (5) feet each side of and abutting the common side lot lines of Lot 1 and Lot 2, West Village Pointe Replat 5, now known as Lot 1 and Lot 3, West Village Pointe Replat 9, both subdivisions as surveyed, platted and recorded in Douglas County, Nebraska. **EXCEPT**, the North Five (5) feet and East Five (5) feet thereof.
