A S S I G N M E N T

SANITARY AND IMPROVEMENT DISTRICT NO. 77 OF SARPY COUNTY, NEBRASKA, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby assign, grant, sell and convey unto SANITARY AND IMPROVEMENT DISTRICT NO. 112 OF SARPY COUNTY, NEBRASKA, all of its right, title and interest, except as herein-after reserved, in and to a perpetual easement for the operation and maintenance of a sanitary sewer line over and across the following described property, located in Sarpy County, Nebraska, to-wit:

A 15 foot permanent easement for sanitary sewer purposes lying in the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Ten (10), Township Thirteen (13) North, Range Thirteen (13) East of the 6th P.M., Sarpy County, Nebraska, the centerline of said easement being described as follows:

Beginning at a point 589.81 feet South and 33.04 feet South 87°17'45" East of the Northwest Corner of said Section 10, said point lying on the East line of the County Road; thence South 87°17'45" East a distance of 2,383.59 feet,

together with all appurtenances thereto, which easement is recorded in Book 33, Page 271, of the Miscellaneous Records of the Register of Deeds of Sarpy County, Nebraska, and which easement was assigned to said District 77 by an assignment found at Book 52, Page 515 of the Miscellaneous Records of the Register of Deeds of Sarpy County, Nebraska; said Sanitary and Improvement District No. 77 covenants that its interest in said easement is free and clear of all liens and encumbrances and that it will warrant and defend

said interest against the lawful claims and demands of all persons claiming by, through or under it, and against no other claims or demands.

Said easement being given for the purpose of allowing Sanitary and Improvement District No. 112 to construct, maintain, operate and repair a 21" outfall sanitary sewer line; Sanitary and Improvement District No. 112 agrees to assume and carry out all of District 77's obligations under and pursuant to the original easement, and above-mentioned assignment.

Said Sanitary and Improvement District No. 77 hereby expressly reserves to itself and its assigns an easement over, upon, and across the above-described property for the purpose of operating, maintaining and repairing its presently existing outfall sanitary sewer line in such easement.

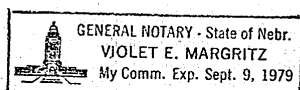

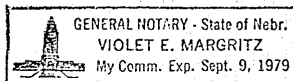
