Beginning at the southwest corner of said Tax Lot 9; thence easterly on the South line of said Tax Lot 9 a distance of 89.9 feet; thence northerly 108 degrees 22 minutes left a distance of 127.0 feet; thence continuing northerly 18 degrees 22 minutes right a distance of 633.1 feet to a point on the northerly property line; thence westerly on said northerly property line a distance of 49.3 feet to a point on the West line of said Tax Lot 9; thence southerly on said West line a distance of 753.6 feet to the point of beginning, containing 39,639 square feet, more or less, which includes 24,829 square feet, more or less, previously occupied as a public highway, the remaining 14,810 square feet, more or less, being the additional area hereby secured.
