The undersigned acknowledges payment of FORTY-EIGHT and no/100 Dollars (\$48.00) hereunder, and it is agreed that if the balance of the stated consideration, \$ none is paid the undersigned within xx days from date hereof, this agreement shall become binding upon all parties hereto, their heirs, successors and assigns, but shall terminate upon the permanent removal or abandonment of the supply or transmission line.
