MEMORANDUM OF OPTION TO PURCHASE

THIS MEMORANDUM OF OPTION TO PURCHASE, dated as of January 22, 2014, is by and between INGERSOLL SQUARE PHASE III ASSOCIATES, L.P. (hereinafter called "LANDLORD") and VERIDIAN CREDIT UNION (hereinafter called "TENANT").

RECITALS

- A. Landlord and Tenant have entered into that certain Lease of even date herewith (hereinafter the "LEASE"), relating to certain office and drive through space located on the real property legally described on Exhibit "A" attached hereto and made a part hereof by reference (hereinafter called "INGERSOLL SQUARE PHASE III"), a portion of which is occupied by the Tenant depicted on Exhibit "B" attached hereto and made a part hereof by reference (hereinafter called the "DEMISED PREMISES"); and
- B. Under the Lease, Landlord granted to Tenant an Option to Purchase the Demised Premises (hereinafter called the "OPTION"); and
- C. Landlord and Tenant now wish to memorialize of record the existence of the Option and certain specific terms thereof.
- NOW, THEREFORE, in consideration of the Lease and other good and valuable consideration, Landlord and Tenant agree as follows:
- 1. Subject to terms and conditions more particularly set forth in the Lease, all of which are hereby incorporated by reference, Tenant may exercise its Option between the Unhindered Occupancy Date, as such term is defined in the Lease, and the date Tenant vacates the Demised Premises.
- 2. Prior to exercising the Option, Tenant shall submit Ingersoll Square Phase III to a Horizontal Property Regime and create a separate tax parcel for the Demised Premises.
- 3. Reference is made to the Lease for a full statement of the terms and conditions of the Lease, all of which are hereby incorporated by reference.
- 4. Nothing in this Memorandum of Option to Purchase shall be construed to amend, modify, change, alter, amplify, interpret or supersede any of the terms and provisions of the Lease, which shall in all things control.

- 5. This Memorandum shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- 6. This Memorandum may be executed in any number of counterparts, each of which is an original, but all of which constitute one instrument.


