

#### MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made and entered into this ZND day of APPL, 2012, by and between ALANDELL PROPERTIES, LLC, successor in interest to Albert L. Feldman and Meyer H. Feldman, Co-Trustees ("Landlord"), and BAG 'N SAVE, INC., a Nebraska corporation ("Tenant").

Landlord and Tenant are the landlord and tenant, respectively, under that certain Lease Agreement dated as of March 17, 1994, as amended (the "Lease"), relating to certain real property located in the City of Omaha, County of Douglas, State of Nebraska, more particularly described in Exhibit "A" attached hereto and depicted on Exhibit "B" attached hereto (the "Property").

Landlord and Tenant desire to have this Memorandum recorded in the Official Records of Douglas County, Nebraska, in order to put interested parties on notice of the rights of both parties under the Lease.

Pursuant to the Lease, Landlord has demised to Tenant, and Tenant leases from Landlord, that certain premises situated on the Property, and being that building and the space therein comprising approximately 42,274 square feet (the "Premises"). Landlord has leased the Premises to Tenant for a term which commenced on February 1, 1994 and which currently expires on January 31, 2019. Tenant has one (1) options to renew or extend the Lease for a period of five (5) years, all subject to and on terms and conditions more fully set forth in the Lease. The Lease is incorporated herein by this reference.

Tenant (or its successor, if any) agrees to execute a recordable termination of this Memorandum upon expiration or earlier termination of the Lease.
