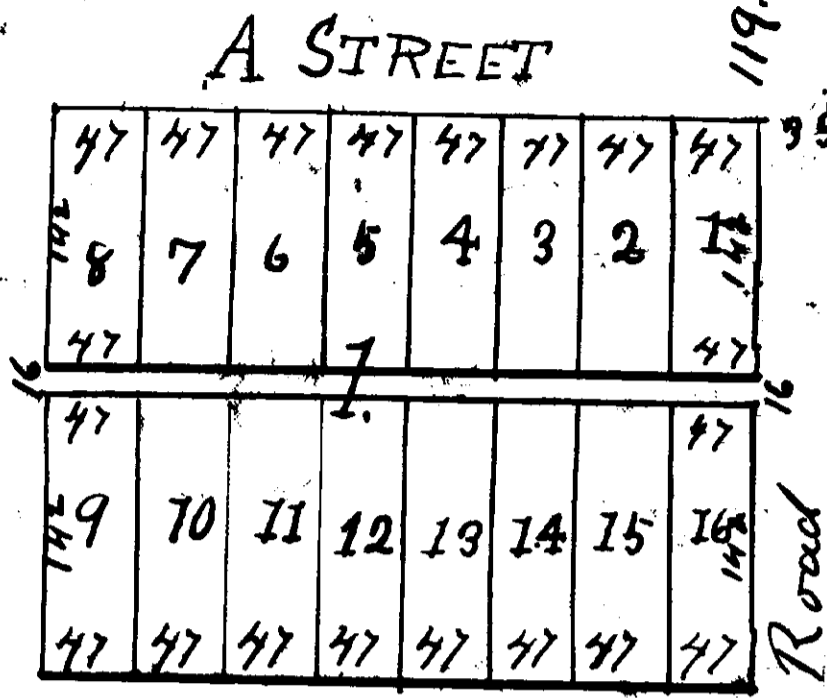


S.S. CHASE'S

142 feet Lot 9 in Block Two (2) is
102 by 376 feet.
