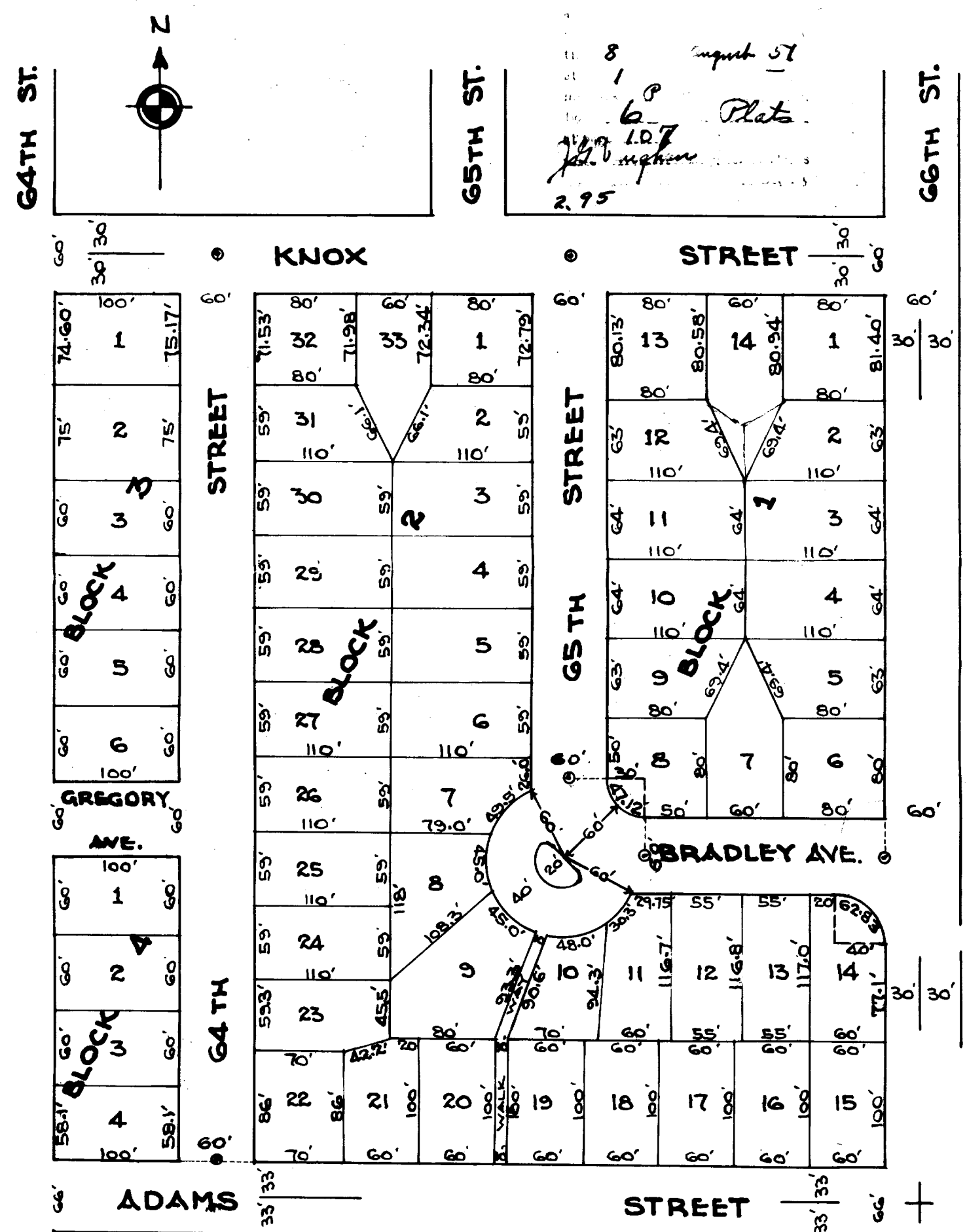


PLAT OF

**DEDICATION**

The foregoing subdivision of Lot 19, Irregular Tract, located in the S.E. 1/4 of Section 9, Township 10 North, Range 7 East of the 6th P.M., Lancaster County, Nebraska, and the platting of the same as Northeast Heights Addition to Lincoln, Nebraska, is with the free consent and in accordance with the desires of the undersigned sole owners and proprietors. The streets and walkways shown thereon are hereby dedicated to the use of the public, together with an easement for the construction and maintenance of sewers, conduits and pole lines, on the following described locations; the rear or west 2 feet of Lots 2, 3, 4 and 5, the rear or east 2 feet of Lots 9, 10, 11 and 12, the south 2 feet of Lot 5, the north 2 feet of Lot 6, the west 2 feet of Lot 6, the east 2 feet of Lot 7, the 2 feet inside the Northeast line of Lot 7, overhang across Lot 7 between the N.W. corner of Lot 6 and the N.E. corner of Lot 8, the north 2 feet of Lot 8, the south 2 feet of Lot 9, the north 2 feet of Lot 9, the south 2 feet of Lot 10, and the south 20 feet of Lot 14, all located in Block 1. Also the rear or west 2 feet of Lots 2 to 9 inclusive, the south 2 feet of Lots 9 to 14 inclusive, the north 2 feet of Lots 15 to 21 inclusive, 2 feet inside the northwest line of Lot 21, 2 feet inside the southeast line of Lot 23, the rear or east 2 feet of Lots 23 to 31 inclusive, the south 20 feet of Lot 33, the south 2 feet of Lots 7 and 26, and the north 2 feet of Lots 8 and 25, all located in Block 2, and the rear or west 2 feet of all Lots in Blocks 3 and 4.
