RELEASE OF EASEMENT

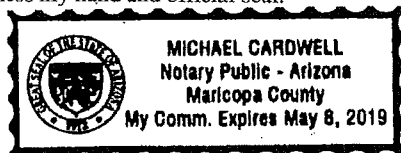
