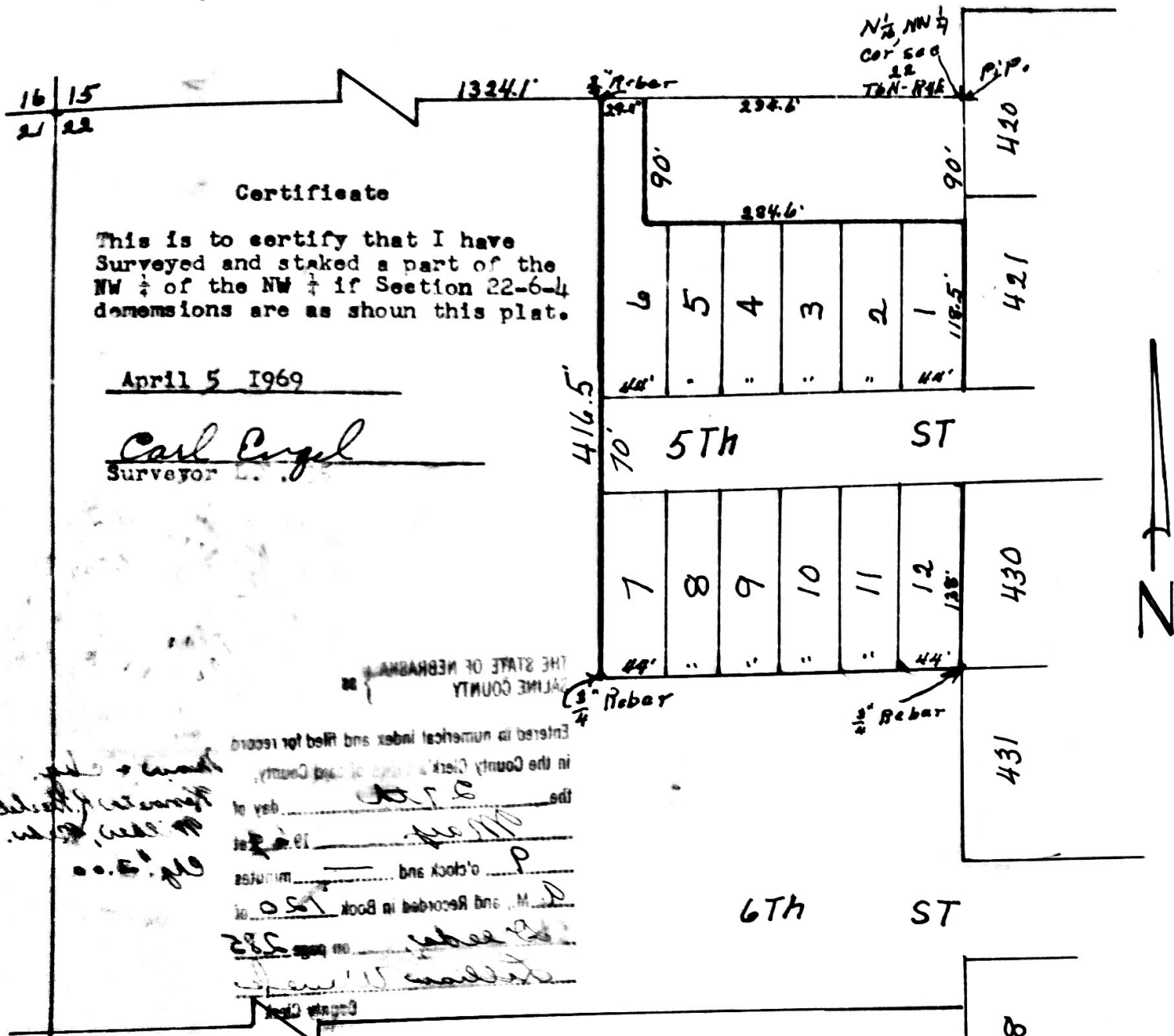


DEDICATION AND PLAT

Commencing at a point Two hundred and sixtyfour (264) feet west of the Northeast corner of the Northwest quarter of the Northwest quarter of section 22 Township 6 north range 4 east of the sixth P.M. Thence south parrallel with the east line of the NW 1/4 of the NW 1/4 416.5 feet, Thence east parrallel with the north line of the NW 1/4 264 feet, Thence north along the east line of the NW 1/4 of the NW 1/4 326.5 feet, Thence west 234.6 feet parrallel with the north line of the NW 1/4, Thence north 90 Feet, Thence west 29.4 feet to the place of begining.
