

**SUPPLEMENTAL AGREEMENT  
Right-of-Way Easement**

This Agreement is made and entered into this 29 day of July, 1993, by and between Nebraska Public Power District, a public corporation and political subdivision of the State of Nebraska and successor to Consumers Public Power District, and John Owen Potter a/k/a J. Owen Potter and Eleanor Potter, Husband and Wife, Grantors, being successors in interest to the original Grantor of a transmission line right-of-way easement granted to Consumers Public Power District, its successors and assigns, which easement is on file and recorded in Deed Book 118, Page 526 in the Office of the County Clerk, Saline County Courthouse, Wilber, Nebraska.

Whereas, in the maintenance and operation of the existing electrical transmission line over and along said right-of-way easement, Nebraska Public Power District desires to relocate and/or replace a structure in the existing transmission line on said right-of-way easement;

NOW, THEREFORE, in consideration of 2500., receipt of which is hereby acknowledged, being full payment for the relocation and/or replacement of a structure pursuant to the grant hereof, the undersigned grantors hereby grant and convey unto Nebraska Public Power District, its successors and assigns, the permanent right, title, and interest to relocate and/or replace a structure in the existing transmission line on said right-of-way easement across the following described property:

The S½ of the SW¼ of Section 30, T8N, R3E of the 6th P.M. in Saline County, Nebraska.

subject to the same terms, conditions, and obligations set forth in said original right-of-way easement unless otherwise expressly provided herein.

One (1) steel lattice structure with four concrete foundations shall replace one (1) existing three pole wood structure with anchors at the point of intersection (PI) of the tangent segments along the centerline of the existing electric transmission line.

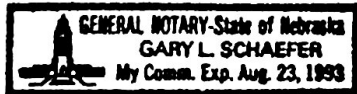
