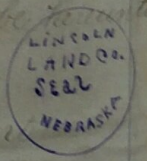

I hereby certify that in the month of
December, 1883, I surveyed the town of
Western situated on a part of the S.W. 1/4
of sec. 15 a part of the S.E. 1/4 of sec. 16,
a part of the N.E. 1/4 of sec. 21 and a part
of the N.W. 1/4 of sec. 22 Township 5 N. Range 2 E. which is clearly shown by
the foregoing plat which is a correct delineation of the survey drawn to
a scale of 180 feet to an inch. The streets and alleys are laid out parallel
with and at right angles to the line between said S.W. 1/4 of section 15
and N.W. 1/4 of section 22 except South Railway St. which is parallel with
the R.R. Burr-Oak stakes are driven well into the ground at the front cor-
ners of each lot and stone are planted low down in the ground at the
several places indicated on the plat. The widths of streets and alleys
and dimensions of lots are indicated in feet and decimals, on the plat
with figures in red ink. Each lot and block bears its own number.
Witness my hand this 7th day of January, 1884. Anselmo B. Smith

plating and dedications as aforesaid are the voluntary act and deed

has hereunto set his hand and caused the Corporate seal to be
affixed this 17 day of January A.D. 1884.

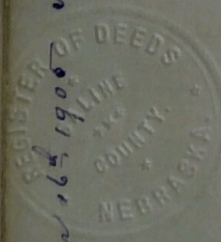
